ANNUAL REPORT

SEASON 1957-58

Gentlemen,

It is with the utmost pleasure that I present to you the Annual Report and Audited Financial Statement of this, the Surf Life Saving Association of Australia, Sydney Branch, for the Season 1957-58.

The Branch has continued to function smoothly and it is once again our proud boast "that no lives have been lost whilst affiliated clubs have patrolled the beaches."

Unfortunately, drowning fatalities did occur during the season, but by virtue of the remoteness of the places and the extenuating circumstances, neither the Association nor its clubs should accept responsibility.

All officers have performed their duties with a high degree of efficiency and devotion, and the result of this efficiency has been reflected throughout the Association and its clubs.

Hereafter is set out for your information matters of importance that occurred during the season.

BRANCH COUNCIL

The Council has continued to meet regularly on the first Tuesday of each and every month, and an enormous amount of work dealt with. Attendances of the delegates and officers as set out elsewhere in this report, has been of a high standard.

Once again I advise that clubs should examine the attendance records carefully and ensure that they elect as delegates to the Branch Council members who they are sure will adequately represent them in this most important of positions.

BRANCH EXECUTIVE

The Executive has continued to function in a highly efficient manner, and has met on each Monday to deal with urgent matters of a current nature. Reports on the Executive's activities have been submitted to the Council and duly acted upon.

My thanks to those officers and delegates who have been so regular in their attendances, and have thus enabled the Executive to carry out its duties competently.

BOARD OF EXAMINERS

The Board of Examiners has once again been a tower of strength to the Branch, and under the careful guidance of its Executive, has continued to meet and cope with an enormous amount of work.

Examinations for awards have been conducted regularly and efficiently, and a large number of carnivals officiated at.

Board of Examiner meetings have been on the whole well attended, and were held regularly during the summer months.

Board Committees executed their duties in an efficient manner, and their reports, when necessary, have been compiled and furnished to the N.S.W. State Centre and National Council.

Office-Bearers of the Board have been set out elsewhere in this report, and to these gentlemen, and also the rank and file members, go our sincere thanks for a task well done.

AFFILIATED CLUBS

All Member Clubs have continued to function efficiently and carried out their rostered patrols and life saving duties at a high standard. Complaints have of course been received from officers on matters affecting clubs, and where necessary such complaints have been investigated and dealt with.

Attendance of delegates to Branch Council are mentioned elsewhere in this report, and they leave a certain margin for improvement.

Overall membership both in active and associates has increased as shown by figures set out elsewhere.

An alarming increase is noted in rescue figures, and clubs are again reminded that prevention of surfers exposing themselves to hazardous conditions is better than a rescue itself. Comparison figures for Seasons 1955-1956, 1956-57 and 1957-58 are set out below.

The intended re-organisation of N.S.W. State Centre and subsequent loss in voting strength of this Branch had repercussions in the 8, 9 and 10 Districts, where a strong move was made to form a separate branch to be known as the Warringah-Peninsula Branch.

Officers attended conferences with representatives of these clubs and placed the Branch's views, which opposed the formation at this time. The fact that the State Centre constitution was eventually redrafted with this branch in a stronger position than ever, did much to take momentum from the formation, and at this juncture the matter has been stood over to some future date.

Advice has since been received from a number of clubs in this area that they have withdrawn their support from the movement. It is hoped that the Branch can continue functioning within its present boundaries for many seasons to come.

COMMITTEES

Branch Committees were called together as the occasion arose, and carried out their duties in a satisfactory manner.

Committees of the Board of Examiners have been mentioned elsewhere in this report, and other committees, including Judiciary, Alternate Accommodation, Finance and Gear Inspection Committees, all met as directed and submitted their reports to the Council. The Gear Inspection Committee in particular was again instrumental in bringing club gear to a high standard early in the season, and the inspection trophy, as donated by Mr. D. C. Lucas, was won by the North Cronulla S.L.S.C. with 9.90 points. Cronulla S.L.S.C., with 9.86 points, was second and Avalon S.L.S.C. with 9.80 points third.

The Gear Improvement Committee considered matters referred to it and have advocated certain changes in Association equipment, these being forwarded to N.S.W. State Centre and National Council for their action.

CLUB SECRETARIES CONFERENCE

Club Secretaries Conferences were convened and held on Saturday, 12th October, 1957 and Saturday, 3rd May, 1958.

Attendances at the latter were rather disappointing as it was felt the operations of the season could have been reviewed whilst details were still fresh to memory.

Certain criticisms were levelled at the holding of such conferences on a Saturday, and it is again explained that an evening meeting is entirely unsatisfactory because of the shortage of time at our disposal and the fact that evenings are unpopular with the majority of secretaries.

The initial conference was well attended and procedures for the coming season were reviewed, stocks of Association Forms, etc., were distributed and I feel its success entirely justified this meeting.

At the conclusion of the conference the majority of secretaries adjourned to the Hotel Metropole where a most enjoyable dinner was had. It is hoped that the conferences and Secretaries' Dinner will become an annual event on the Association's calendar and thus serve the twofold purpose of allowing secretaries to meet socially and clarify their duties for the season also.

AMATEURISM

During the season the National Council investigated the matter of amateurism as effecting our members and in view of the subsequent decision arrived at, the following definition has been promulgated to other sporting bodies both here and abroad.

"ALTERATION TO NATIONAL COUNCIL CONSTITUTION RE AMATEUR DEFINITION OF LIFE-SAVERS:

"In view of the voluntary and humanitarian service rendered to the general public by members of Surf Life Saving Clubs affiliated with the Association and of the desirability of such members maintaining the maximum efficiency in order to fit themselves for this task and of fostering and advancing the work of Surf Life Saving such members are acknowledged as members of the services

or defence forces and accordingly eligible to take part in all surf life saving displays and competitions conducted by the Association in accordance with its rules."

CARNIVAL DATES AND VENUES FOR SEASON 1957-58

Twenty-two carnivals were conducted in the Branch last season and are set out as under.

The large number of carnivals undoubtedly placed a burden upon members of the Board of Examiners who unfailingly officiated, but also had a happy aspect of bringing competition standard to a very high degree. The success of members of this Branch at State and Australian Championships, is no doubt due largely to this competition at open carnivals.

Restrictions were not placed upon country branches' visits, and it is pleasing to note the clubs from Illawarra, Central Coast and Newcastle, as well as individual members from further afield who competed in our carnivals, were extended every hospitality by the host club.

Carnival venue brochures were printed at the commencement of the season and our sincere thanks are extended to Mr. R. Bunt, of Jantzen (International) Pty. Ltd., whose ready support made the brochure possible.

GOLDEN JUBILEE APPEAL FOR FUNDS

As mentioned in the 1956-57 report, a public appeal was made for funds during the Jubilee Year.

A suitably worded letter was directed to prominent business houses and citizens of the City of Sydney, and despite the generosity of certain persons, the appeal was not the success one would have anticipated.

The final figure of $\pm 513/14/$ - represented 72 donors out of the hundreds of letters forwarded.

As this figure included such generous donations as the Colonial Sugar Refineries ($\pounds 100$), Australian Glass Manufacturers Pty. Ltd. ($\pounds 50$) and Eveready Batteries Pty. Ltd. ($\pounds 50$), it can be seen that the remainder of donations were comparatively small.

It is most pleasing to report the number of firms who have placed this Branch on their annual donation list, and to these people and to everybody who contributed, we again say "thank you" for assisting us in our work.

RESIGNATION OF Mr. C. MACK

It will be with sincere regret that the Annual General Meeting will learn that Mr. C. Mack will not seek re-election to the position of President.

Mr. Mack is possibly one of the best known personalities in the movement today, having served as Deputy President to His Honour Judge Curlewis in the Head Centre until its disbanding, whereupon he was elected as President to this Branch, a position he has held for nine consecutive seasons.

Mr. Mack served as Deputy President to N.S.W. State Centre for a time, and also has been a Vice-President of that centre since its formation.

A Life Member of the Association, Cecil Mack is still a respected member of the North Bondi Club and has guided this Branch through many hazardous ventures.

Active association with clubs and their parent body over a period of thirty years has won for him the love and respect of every member of this Branch.

N.S.W. STATE CENTRE

Much of the interest in the N.S.W. State Centre this season has been focused upon the suggestion and subsequent actions to re-organise the State Centre on lines more closely resembling that of National Council. The suggestion was originally made by Mr. K. Watson of the Central Coast Branch, and two conferences of representatives of branches were subsequently held to consider the matter.

It was first intended that all branches should be equally represented by one delegate to the Management Committee and two delegates to Council. Voting powers of officers were cut and on these two matters the Branch strongly opposed any alteration. After considerable discussion and investigating findings of committees set up to report on the matter, a redrafted constitution has been prepared and circulated to all State Centre officers, branches and delegates.

It is intended at this juncture that the amended constitution will be presented to the N.S.W. State Centre Annual General Meeting, to be held in Terrigal on Saturday, 18th October, 1958.

It need not be explained what importance a re-organisation of State Centre would be to Sydney, and it is pleasing to report that the redrafted constitution as it now stands allows double representation for this Branch in both administration and State title events 1-8.

Another factor worthy of note is that under the intended constitution the only officers who have the right to vote will be the President, Hon. Secretary, Hon. Assistant Secretary/Registrar, Hon. Treasurer, Hon. Superintendent and Deputy Superintendent.

Other activities have been carried out capably by the State Centre and we again extend our congratulations to the new President, Mr. T. W. Meagher, who is also a Life Member and Vice-President of this Branch. Congratulations are also extended to the Hon. Secretary, Mr. B. Brewin; Hon. Treasurer, Mr. E. Lawler; and to all other officers who so diligently carried out their duties during the 1957-58 season.

NATIONAL COUNCIL

The National Council has continued to function in an efficient manner and the Association generally has been kept abreast of its developments by means of regular bulletins.

Our congratulations are extended to the Hon. Secretary, Mr. K. W. Watson, for his difficult task well done; and to Mr. R. Brydon, newly elected Chief Superintendent, for his effective handling of matters in his inaugural season.

Advices from the National Council by means of bulletins and minutes reveal that the 1959 Australian Titles will take place at Mooloolaba Beach, Queensland, on the 28th and 29th March (Easter weekend). Preliminary organisation in connection with this venture is well advanced and clubs have already been circularised regarding transport facilities and the availability of accommodation. For the year 1960, the Australian Titles have been allocated to the Newcastle District Branch and it is understood the fixture will take place at Merewether Beach.

In pursuance of the policy of giving ample notice to all State Centres, National Council also advises that the 1961 Australian Championships will take place in the State of South Australia on a beach yet to be determined.

Some slight alterations have been made to the conditions governing interstate contests with a view to creating more interest in this feature of Australian titles. The new scheme will be given a trial at the championships in Queensland next year.

INSURANCE

Having regard to the increase in the number of active members appearing in the annual schedules, the National Council has found it necessary to limit its liability with respect to assistance with life insurance, and the matter is to be reviewed annually in light of funds available. For the year ending 1957 the sum of £1,973 was paid to the New South Wales State Centre for this purpose. Unless some additional financial assistance is forthcoming from the Federal Government, consideration will have to be given to curtailing this assistance to State Centres.

The 1957 Annual Meeting of National Council was held in the City of Newcastle and the 1958 meeting is scheduled to take place at Wollongong on the 22nd November, and this function will be followed by the Annual Dinner of National Council, which will act as a welcome home to the President, Judge Curlewis, following his world tour.

JUDGE CURLEWIS' OVERSEAS TRIP

Prior to departing from Australia in March last, a function was tended to Judge Curlewis at the Hotel Australia and many representatives of the Sydney Branch were in attendance. A presentation was made on behalf of the New South Wales State Centre and on the same occasion a presentation was also made to the retiring Chief Superintendent, Mr. Victor Besomo, in appreciation of his valued services to the Association over many years.

During his visit overseas Judge Curlewis has carried out many duties on behalf of the Association generally. Whilst in Ceylon, a fully equipped reel, line and belt was presented to the Association there as a donation from the Orient Line.

On the 17th July films depicting Australian surfing scenes were screened at the request of the Duke of Edinburgh at Buckingham Palace. Following this Judge Curlewis visited Germany, where the same films were shown to various German youth movements there.

Returning to England, he attended the 1958 championships of Great Britain at Perranporth, which were scheduled to take place on the 27th July, but were virtually abandoned on account of very adverse weather. In all, 17 Australian lifesavers had been contacted in London and ten of them actually presented themselves in Cornwall.

A visit was also made on the 21st June to the Jersey Isles, where very favourable publicity resulted from this trip. These ventures were followed by the presence of Judge Curlewis on the Continent where, with the assistance of many other Australia surf lifesavers, including principally those from the Sydney Branch, endeavours are to be made to establish Australian surf life saving methods at Biarritz in the Bay of Biscay.

Judge Curlewis is scheduled to return to Australia from London on the 18th September via the United States and Honolulu and will arrive in Sydney on the 15th November.

INTERNATIONAL

Apart from the above developments overseas, considerable activity has taken place on an international basis with South Africa, New Zealand, the Jersey Isles, Ceylon and Great Britain, and enquiries from many other quarters are being received by the National Council almost daily, and these include Borneo, Trinidad, Chile, Wales, Scotland, Ireland, Accra, Portugal, Singapore, New Guinea, Karachi, Germany, Canada and the U.S.A.

BRANCH GOLDEN JUBILEE DINNER

The Golden Jubilee Dinner of the Branch was held in the Hotel Metropole on Thursday, 17th October, 1957, and was largely attended by Association members as well as civic dignitaries.

The Branch was honoured to have as its guests on this occasion, The Premier of N.S.W., The Hon. J. J. Cahill; The Right Hon. The Lord Mayor of Sydney, Alderman H. F. Jensen; His Worship The Mayor of Waverley, Alderman K. Anderson; His Worship The Mayor of Randwick, Alderman W. Lucas; His Worship The Mayor of Manly, Alderman M. Payne; The President of the Sutherland Shire, Councillor J. Dwyer; and Councillor Reynolds, of the Warringah Shire.

The toast to the Association was proposed by the Premier and supported by the Lord Mayor and other local government representatives.

In the proposing of the toast and its support, visitors were lavish in their praise of the magnificent work done by the Association throughout the years. Application for its use at Wiley Park Oval have been received and it is to be hoped that during the coming season clubs will avail themselves of this valuable asset.

To Mr. J. Dempster we again extend our sincere thanks for his many efforts and also to Mr. L. Muras our appreciation for allowing the seating to be stored on his premises.

PUBLICITY

The difficult task of obtaining sufficient coverage in the daily Press and other publications was ably handled by our Publicity Officer, Mr. M. George.

It is, of course, appreciated that the various sections of the Press do not consider the surfing movement as a field for sensationalism and the subsequent coverage is small.

Thanks must be extended, however, to the Truth and Sportsman, the Sun and the Sydney Morning Herald, who did have a weekly column devoted to news from the clubs.

Whilst speaking of publicity one could not help but mention the splendid co-operation extended the Association by Mr. W. Stevenson, General Manager of Radio Station 2SM. The surfing programmes on Saturday and Sunday afternoons, so capably compered by John Brennan and Tony Withers respectively, were of immense help in bringing club news to the general public.

ROGER MORONEY DINNER

On the 25th June, 1958, a very successful and well attended dinner was given for Life Member, and very popular, Roger Moroney.

The function, which was held in the Gloucester Room of the Hotel Australia, was a fitting tribute to a member who has given unselfishly of himself and his time for so many years.
