

ANNUAL REPORT

To be presented to the 10th Annual General Meeting of the Sydney Branch, to be held in the Australian Historical Society Auditorium, No. 8 Young Street, Sydney, on Thursday, 1st October, 1959, commencing at 6.30 p.m.

Gentlemen,

It is with a great deal of pleasure that I present on behalf of the Branch Council Officers and Delegates this, the 10th Annual Report for the Season 1958-59.

The Branch has continued to function smoothly and has administered to its Clubs in all matters appertaining to Life Saving.

All Officers have performed their duties to a high degree of efficiency and devotion and their efforts have been reflected throughout the Association and its Clubs.

During the month of June, a meeting was called by the North Steyne S.L.S.C. of all Northern Clubs to discuss the proposal of forming a Northern Side of the Harbour Branch which would seek affiliation direct with the N.S.W. State Centre. Two meetings were held and on the second occasion eleven of the twenty Clubs in the area carried a motion that an application should be lodged to seek affiliation for the Manly-Warringah Districts.

The request for this affiliation was tabled at the August Council Meeting and the question of whether the application should be opposed or supported by this Branch was keenly debated. A motion was subsequently carried by a substantial majority that "The affiliation be forwarded to the N.S.W. State Centre in accordance with Constitution but that the Branch register the strongest possible disapproval."

A decisive feature of the voting on this matter was the strong opposition of the Northern Clubs, who dissented from the application at the North Steyne Meeting.

As this report goes to print a Committee has been formed by the Branch to prepare a case to place before State Centre, and, it is hoped, that in view of the official opposition of the Branch and particularly because of the number of Clubs in the area that are in dissent, that the application will be refused.

The functions and duties carried out by the Branch during the season have been many and varied and hereafter is set out for your perusal matters of importance.

BRANCH COUNCIL

The Council, which is the governing body of Association affairs in this Branch, continued to meet regularly on the first Tuesday of each and every month and an enormous amount of matters were dealt with.

Attendance of the Delegates and Officers of the Council have been of a comparatively high standard, and such attendance details are set out elsewhere in this Report for Clubs' perusal.

It is indeed unfortunate that many Clubs do not take a proper interest in Association affairs and tend to become parochial in their outlook. The position of Delegate to the Association should be one of great importance among Club Officers and it behoves all Clubs to ensure that they are well represented in this sphere.

Branch Bulletins have been circulated regularly each month, but in some cases Clubs awaited receipt of these Bulletins rather than being advised by their Delegates. This, to a degree, has prevented some Clubs from discussing matters prior to their finalisation at the Council.

The practice of calling for a Delegate's report at Club Committee Meetings is suggested, for the two-fold purpose of ensuring a familiarity with Association affairs and ensuring delegates' full representation.

BRANCH EXECUTIVE

The Branch Executive has met regularly each Monday during the lunch-hour and the volume of matters attended to can be borne out by the Minutes of these meetings.

It should be remembered by all that the functions of the Executive are primarily to deal with matters of pressing importance and of a routine nature pending their discussion at the Council, and to dispense with matters that would normally consume valuable time at Council meetings.

A report on the Executive's activities was submitted to each Council meeting and items of particular interest to Clubs could be again brought up for discussion.

My thanks go to those Officers and Delegates who have been so regular in their attendance and thus enabled the Executive to carry out its duties competently.

BOARD OF EXAMINERS

The Board of Examiners, under the capable leadership of its Executive, including Mr. E. J. Marsden — Branch Superintendent, Mr. H. McDonald — Deputy Superintendent, Mr. A. Moseley — Hon. Secretary, and Messrs. K. Flannery and R. Cosgrove, Southern and Northern Side Supervisors respectively, together with their District and Assistant Supervisors and rank and file members, have been responsible for carrying out an enormous number of Examinations, officiating at Carnivals, etc. The Board of Examiners are a very effective "Right Arm" of the Branch, and the schedule of awards as set out elsewhere in this Report will bear testimony to their diligence. Board Committees executed their duties in an efficient manner and their reports, when necessary, have been compiled and forwarded to the N.S.W. State Centre and National Council.

Board of Examiners' Meetings have been well attended and were held regularly during the summer months, the Board being in recess during winter.

AFFILIATED CLUBS

All Member Clubs have functioned efficiently and have carried out their rostered patrols and life saving duties to a high standard.

Complaints were received regarding patrols on certain beaches and these matters have, of course, been investigated and attended to. The conditions for patrolling a beach as laid down by the Association are subject to dispensation and many Clubs have applied for exemption from certain aspects of these conditions.

A notice of motion was tabled during the season concerning the patrol year and was subsequently carried, the clause reading, "The Patrol Season shall be from at least the first day of October to the end of April in the next succeeding year." The condition is now mandatory upon all Clubs.

Set out below is a summary of Rescue Figures for the season compared with previous years and increases are noted in all spheres apart from "With other Gear." Surfing conditions throughout the season were consistently moderate and the increase in these rescue figures could be contributed in no small way to the undoubted gain in popularity of surfing on our beaches.

COMMITTEES

Branch Committes were called together as the occasion arose and carried out their duties to a high degree of efficiency.

Committees of the Board of Examiners have been mentioned elsewhere in this report and other Committees met as instructed and submitted their reports to the Council.

The Gear Inspection Committee, in particular, was again instrumental in bringing Club Gear to a high standard early in the season, and the Inspection Trophy, as donated by the Deputy President, Mr. D. C. Lucas, was won by Manly S.L.S.C. with 9.94 points. North Steyne and Queenscliffe Clubs were second and third respectively. A Boat Committee was formed during the latter part of the season to consider matters referred to it by the National Council and their findings have been forwarded to that body.

ASSOCIATION AWARDS

As will be borne out by the figures listed below, the number of Awards in all spheres rose considerably above last season. Bronze Medallions were almost a 100 greater as were Qualifying Certificates. Congratulations are to be extended to certain Clubs and their Chief Instructors for the high percentage of Association Awards gained, and in particular one should mention Collaroy with 29 Bronze Medallions, Cronulla with 38, Maroubra with 38, and North Cronulla with 50.

The procedure for requesting the examination of Club Squads was altered early in the season and appeared to function quite smoothly throughout the year. Certain modifications were made in an attempt to streamline the granting of awards, most noteworthy of which was the Branch invoicing Clubs for their awards rather than to accept a cheque at the time of the examination.

PROCEDURE FOR ASSOCIATION EXAMINATIONS

Following upon recommendations from the Board of Examiners tabled at the June Council Meeting, all Clubs were subsequently advised that "In order that squads for examinations may be brought to a maximum efficiency, Clubs are directed to ensure that all squads under the care of a Probationary Instructor be also under the supervision of a Qualified Instructor. Also that a Qualified Instructor should accompany the Squads for their examination."

An Examination Procedure Committee was formed during the latter part of the season and new forms have been compiled and forwarded to N.S.W. State Centre with a request that this Branch be allowed to use such forms for a trial period of twelve months. It is anticipated, if this request is granted, that the Branch will be in a position, by virtue of its experience with the forms, to suggest a number of simplified methods for future use.

Special thanks must be extended to Mr. J. Vaughan for his research in this regard.

In addition to these Carnivals the State Championships were held at Wanda Beach as has been mentioned elsewhere in this Report.

The large number of Carnivals undoubtedly placed a great burden upon Board of Examiner Members, who officiated without failure, and on Competitors alike. However, outstanding success of Members of this Branch at State, Australian and Interstate Carnivals is no doubt due, to a large degree, to this competition at open Carnivals. Again, no restrictions were placed upon Country Branches' visits, and it is pleasing to note that Clubs from these Branches were again extended every hospitality by our Clubs. By the co-operation of Mr. R. Bunt, Advertising Manager of Jantzen, the Carnival Venue Card was printed at the commencement of the season, and the inclusion of Carnival Dates for the Far North, Mid-North, Newcastle, Central Coast, and Illawarra Branches, made the card a highly successful feature.

"RASTUS" EVANS MEMORIAL TROPHY

As mentioned in the previous Annual Report a Trophy has been made available for competition between Junior Boat Crews by the brother of the late "Rastus" Evans. Points were allocated for junior Boat Races at all Branch Open Carnivals and to the winners, the North Bondi S.L.S.C., go the Branch's congratulations on their victory for the second year in succession.

It is the intention that the Trophy should be presented to the members of the winning crew at the Annual General Meeing.

Place Getters were as follows :—
1st — North Bondi, 27 Points.
2nd — Warriewood, 25 Points.
3rd — Wanda, 21 Points.

ASTOR BOAT COMPETITION

Through the kind efforts of Mr. C. C. Zahara, the General Manager of Astor Radio Corporation, the Branch was again presented with a fully equipped surf boat and in continuation of their similar presentation for last season, this boat was very aptly named Miss Astor II. The Competition was taken over all Open Carnivals conducted in the Branch, with the exception of Garie, and a handicap system again ensured all Clubs an equal opportunity.

Results of the Astor Boat in points scored are as under :--

1st, Cronulla — 221 Points (Ineligible).

2nd, Freshwater — 207 Points.

3rd, Clovelly — 184 Points.

4th, Wanda — 176 Points.

Since the conditions of the BP Boat Competition stipulated that a Club was ineligible to win two boats in the same season, the Cronulla Club were unable to accept this craft, and the boat was awarded to the Freshwater Club. Congratulations are extended again to the Freshwater Club on its success in this competition. To Mr. Zahara and the Astor Radio Corporation we can only repeat our grateful thanks for their recognition of this Association in such a tangible manner.

BP BOAT COMPETITION

The Branch was indeed fortunate to have two fully equipped boats available for competition this season, and we are greatly indebted to the Directors of BP Limited for their wonderful donation.

Conditions for this Boat were altered from those of the Astor Competition and were allocated on a straight point score basis. Congratulations are extended to the Cronulla Club, which top-scored in both Boat Competitions, but as has been mentioned elsewhere, were unable to accept the Astor Boat.

Following upon this donation to the Branch, the National Council were advised during the latter part of the season that the BP Company was donating 27 Boats and 54 Reels for competition throughout Australia, in the next three years.

This most generous donation, valued at approximately £18,000, will be of tremendous assistance to our Clubs, and in conditions recently completed, the Sydney Branch has been allocated a fully equipped Boat and two Surf Reels.

JANTZEN AND RADIO 2SM TROPHIES

We were fortunate in having donated at the commencement of the season trophies by the above companies, and the Jantzen Trophy which comprised a pair of terylene tricot trunks was given to the winners of the Novice Surf Race at each of the Open Carnivals.

The 2SM Trophy, which was to the value of £5/5/0, was allocated for various events over the season of Open Carnivals.

To Mr. R. Bunt, of Jantzen International, and Mr. W. (Bill) Stevenson, Manager of 2SM, we extend our sincere thanks for the interest they have shown in our movement over a number of years, and we assure them that enthusiasm for their trophies was at its highest.

BEACH FOOTBALL — DICK'S SHOES TROPHY

The Competition referred to in the 1957-58 Annual Report was won by the Maroubra S.L.S.C., and as this was their third victory in four years, the inaugural Dick's Shoes Trophy has now been retained by the Club permanently.

Our sincere appreciation is extended to Mr. R. (Dick) McPhillips for his wonderful generosity in making a further trophy available for this competition, which is fast occupying a most important position in our winter activities.

Clubs competing in the present competition include North Bondi, Bronte, Maroubra, South Curl Curl, Coogee, Bondi, and Clovelly. As the report is prepared for printing, the semi-finals have been reached with joint leaders North Bondi and Bronte, with Maroubra and Bondi occupying second place.

To our Chief Referee, Mr. John Manjioni, and his assistants, we extend our thanks for a difficult task well done, and to all Members who assisted and took part in the Competition, we are indeed grateful.

METROPOLITAN CHAMPIONSHIPS

The Metropolitan Championships were this season conducted under most trying surfing conditions at the Dee Why Beach on the 14th February, 1959. To the Carnival Organisers, Mr. B. Pitt and Mr. L. Beard, and indeed to all Officers and Members of the Dee Why Club, goes our appreciation of a most difficult task well done. The Branch Superintendent, Mr. E. J. Marsden, and members of his Board were in attendance at the Beach at an early hour and ensured that the events were conducted as smoothly as possible. It was, however, impossible to finalise the programme, and certain events had to be postponed, to be held at Manly on the following day, where it is worthy of note that conditions were still of such a nature that the events had to be further transferred to Freshwater Beach. The congratulations of the Branch are very sincerely extended to the Board of Examiners for their extremely capable handling of the Carnival under these conditions.

At the conclusion of the day, near disaster was only averted by the selfless devotion to duty of members of a Boat Crew, comprising Messrs. B. Bryant (Sweep), T. Wise, Nelson Chad, Ken Small and T. Tibbles, who put to sea with the knowledge that if they should flounder, no help was available to them, and yet they proceeded to carry out a rescue of a boat crew that had been stranded in the lee of the "Pebble," mid-way between Dee Why and North Curl Curl Beaches. The bravery of this Boat Crew was such that their actions were forwarded to the Meritorious Awards Committee, and they have been issued with letters of commendaion on behalf of the Branch.

Trophies were distributed on the day and members of the Official party and representatives of local bodies were entertained in the Dee Why Club House by the Ladies of the Auxiliary. Below will be found the results of the Championships and the Branch again congratulates Clubs and Members who competed so successfully.
