

ANNUAL REPORT

Gentlemen.

It is with mixed feelings that I present to you the Eleventh Annual Report of the Sydney Branch, representing our fifty-third year of operation.

The season 1959-60 has been a truly momentous one for the Sydney Branch and we have experienced great triumphs and suffered severe set-backs. The most important event of the season was undoubtedly the formation of the Manly-Warringah Branch of this Association and its resulting withdrawal of the affiliation of the twenty Northern Side Clubs. The events leading up to the formation of this Manly-Warringah Branch will be dealt with under separate headings below.

Another important item of the season was the compilation and subsequent adoption of a revised Constitution and this matter also is dealt with under separate heading.

The Branch has continued to function smoothly with what could be called its usual efficiency, and has administered to its Clubs in all matters appertaining to Surf Life Saving. It has served the New South Wales Centre and the National Council wherever the opportunity occurred.

It is pleasing to report that all Officers have carried out their duties in the most efficient of manners and their efforts have undoubtedly been appreciated and responsed to by fellow Officers and Clubs alike.

It is, I feel, correct to place on record that both Officers and Clubs alike look forward to the season 1960-61 with a great deal of anticipation and we trust it will be the beginning of a new era for the Sydney Branch.

We trust we will achieve by our close unity with our member Clubs, and by the strongest possible efforts on the part of all concerned, an even greater efficiency and harmony than has been evident in the past.

The functions and duties carried out by the Branch during the season have been many and varied and, in keeping with the recog-

nised style, each item is dealt with under separate headings as follows:

BRANCH COUNCIL

The Council, which is the governing body of the Association affairs in the Sydney Branch, has continued to meet regularly on the first Tuesday of each and every month and an enormous amount of matters have been dealt with.

It is to be regretted that we must record that attendance of Officers and Delegates in some instances has left much to be desired. Indeed, the position became so acute that, after the June council meeting, our President, Mr. A. R. Loton, was forced to write to the Presidents of the affiliated Clubs, reminding them of their obligation, firstly, to be in attendance at the Branch Council themselves in their capacity as Vice-Presidents, and also requesting their support in ensuring their Club Delegates adequately represented their Club. There were, of course, the Officers and Delegates who have been outstanding and most regular in their attendances throughout the years. To these gentlemen, we extend our heartfelt thanks for their continued co-operation and assistance that is of the utmost importance to ensure the smooth running of the Branch and to keep the Council meeting as a truly representative one.

The Branch monthly circular has continued to be the regular organ from the Branch and has been circulated prior to each Council meeting. Clubs are again reminded that many matters contained in the circular are submitted for official confirmation only and should be in addition to their Delegates' report.

As I have stated previously, the practice of calling for a Delegate's report at Club committee meetings should be a necessity, for its two-fold purpose of, firstly, ensuring a familiarity with Association affairs and, secondly, to ensure that their Delegates are adequately representing the Club on the Council.

BRANCH EXECUTIVE

The Executive has continued to meet on the Monday of each week during the lunch-hour and the amount of work that has been performed by this body can be borne out by the minutes of their meetings.

The Clubs are entitled to six Delegates to represent them on the Executive. During the season four only were nominated to this position and the year was completed, therefore, with two vacancies existing.

The functions of the Executive are to deal with matters of importance or of a routine nature. An Executive report, covering as extensively as possible the activities during the month, has been submitted to each Council meeting for ratification of Delegates and Officers.

My thanks go to those Officers and Delegates who, by their regular attendance at these meetings, have enabled the Executive to carry out its duties in such a competent manner.

RESCUES

A comparison of rescue figures throughout the past five years is set out as below. It is pleasing to report that, whilst the members of the surfing public, who enjoy Australia's national past-time, has continued to grow, the rescue figures have been kept at a comparatively steady level, and have shown little alteration in pattern throughout recent years.

To the members of our patrols, we are indeed grateful and justly proud of their attention to the fundamental aims of this Association.

BOARD OF EXAMINERS

The ranks of our Board have, of course, been depleted following the official formation of the Manly-Warringah Branch during May of this year, but it is anticipated that we have ample Examiners to carry out duties for the next season and to meet the various matters that arise from time to time that necessitate the investigation and action of our Board members.

Since this will be the last occasion when we can speak of the Board of Examiners, both north and south, as a single body, it is, I feel, fitting that we should record the names of these members who constituted our Board at the time of the formation of the Manly-Warringah Branch. BP SURF REEL COMPETITION

We were pleased to receive this season the first of the items of equipment that are to be allocated to Sydney Branch for competition purposes over three seasons. This gear is part of the wonderful donation of BP Australia Limited to the Surf Life Saving Association of Australia. The total donation is £18,000.

This year's competition, which was conducted on a point-score basis covering open carnivals, was won by the Bronte S.L.S.C. with 17 points. Freshwater S.L.S.C. and Manly S.L.S.C. were second with 15 points, and Cronulla S.L.S.C. were fourth with 12 points.

A further reel will be competed for in the season 1960-61, and in the season 1961-62 we will receive a fully equipped surf boat.

This most generous donation from BP Australia Limited is part of their donation of twenty-seven surf boats and fifty-four surf reels that will be competed for throughout Australia during the next two seasons and the season just concluded.

The participating organisations included: N.S.W. Electricity Authority, N.S.W. Ambulance Transport, N.S.W. Police Department, Royal Navy, N.S.W. Amateur Swimming Association, N.S.W. Fire Brigade, Royal Australian Navy, Royal Life Saving Society, the Surf Life Saving Associations of Australia, Ceylon, New Zealand and South Africa, the Underwater Research Group, Hong Kong Life Saving Association, the Underwater Spear Fishing Association, and the Japanese Life Saving Association.

A number of Committees were set up to investigate aspects of the matters to be considered and the reports of these Committees were then presented to the Convention.

The findings of the Convention and its endorsement of the oral techniques of resuscitation, namely mouth-to-mouth and mouth-to-nose, is now well known to our members and an enormous programme now confronts the Association in re-training our members to these new methods.

To the members of the Committees, to the assisting bodies and, in particular, to the Chairman, His Honour Judge A. H. Curlewis, the National Secretary, Mr. K. W. Watson, the Hon.
