

#### FOREWORD



The ensuing report will show that the work of the Sydney Branch, both in the Clubs and the Association itself, has prospered. ...On the other hand, there are certain elements of disquiet which should, if possible, be eliminated by incoming Officials. The drop in awards gained is no doubt due in part to early season difficulties with the new drill methods and the lack of handbooks. The severance of the northern section of the Sydney Clubs into the newly-formed Manly-Warringah Branch appears in no way to have affected the administrative efficiency of this Branch and its Board of Examiners, and perhaps has made the duties of officials easier. It is interesting to note the move to have carnivals on both sides of the Harbour open to all Clubs.

Clubs should, I think, be governed on the basis of advancing both their own local interests and Association affairs generally for the two are very closely interwoven and should be able to provide members to share in the Association's administration. I would also suggest that Clubs endeavour to blend youth with experience with an eye on future benefits.

May next season surpass the last.

#### ANNUAL REPORT

To be presented to the 12th Annual General Meeting of the Surf Life Saving Association of Australia, Sydney Branch, to be held in the Association Rooms, Underwood House, 16 Hunter Street, Sydney, on Tuesday, 5th September, 1961, commencing at 7.00 p.m.

Mr. President,

Gentlemen,

I have pleasure in presenting for your perusal and intended adoption the 12th Annual Report marking the 54th year of operation in the Sydney Branch.

It has become evident during the past season that the problems that beset this Association are not declining over the years, and we can only trust and hope that all officers and members will continue to give to this Branch the benefit of their experience and understanding in overcoming these trials.

The Sydney Branch has continued a most active interest in the affairs of this Association in all spheres, and indeed we have on occasions been accused of paying too much attention to matters that do not directly affect us.

Despite this criticism Sydney Branch defends its right to exercise interest in matters that happen anywhere in Australia if we feel that repercussions are being started or decisions being made that could affect our Clubs' interest.

It is impossible for Sydney Branch, which was once the hub of the whole movement and its birthplace, to adopt an attitude of apathy, but rather, I feel, that we must continue to exercise the right of our heritage and play a most active part in the writing of the history of this great movement.

On occasions Sydney Branch has launched matters into the State sphere and have not received the expected support of fellow Branches. This lack of support is, we fear, brought about by an attitude that is becoming more evident in Club, Branch and even State levels of not adopting a point of view that is for the ultimate good of the movement on a whole.

It would be unfair to criticise further afield for this attitude when we have the same problem within our own Branch.

At the commencement of this season appeals were made to the Clubs to become a part of a more closely united group, and we looked forward to a strong, almost social-like bond being established.

On the whole it is evident that this bond has been welded and, we trust, can be maintained and strengthened in the future.

In a changing world such as we live in to-day, particularly with the diversity of interest available to our young men, this Branch nor the Association will be able to carry "Passenger" Clubs, but rather one and all will have to realise their responsibilities.

Association officers and members will be called upon more and more to sacrifice their valuable time and render assistance to our Clubs.

Clubs will very shortly realise that many of their problems, particularly with respect to Club membership, is something that cannot be met and defeated in their own area, but will necessitate a guided and wise programme on an Association level.

Membership figures as set out in this report will prove beyond doubt that our Club membership is not on the same overall increase that it should be.

All too often one hears the remark from Clubs that their membership is of a suitable strength and their interest in the overall problem is non-existent.

It is, I feel, sufficient to say that every Club should keep a careful eye on this matter and wherever possible benefit from the mistakes of others.

Support of the Association has not been as strong as would be expected, and in requesting greater support in the future we also assure the Clubs that from a Branch level we are most mindful of their domestic difficulties, but urge them nevertheless to exercise greater interest in Association developments.

Club secretaries have on many occasions failed to act with the required promptness to directions or requests from the Branch, and this tardiness has made it more difficult to arrive at the most beneficial decisions.

We trust that by mutual effort and greater co-operation to effect an ultimate harmony, and one and all from the Patrolling Club Member to the highest Association Officer is asked to lend his support.

Hereafter will be found items of interest which occurred during the season set out in a fashion, I trust, will be simple to follow and informative.

#### BRANCH COUNCIL

The governing body of the Surf Life Saving Association in the Sydney Branch has continued to be the Branch Council which has met regularly each and every month.

The attendance of delegates has been of a comparatively high level, but much has been left to be desired with a minority, and as in previous years Clubs are earnestly requested to examine the attendance records set out elsewhere in this report and judge for themselves if they have been adequately represented.

Branch officers have been represented at the Council Meetings to a high standard, and we trust that this attendance of officers at meetings which has become a pleasing feature over the years will be continued.

Special mention must be made of the Club Presidents who occupy vice-presidentship by virtue of their position, and it is regretted that two-thirds of these gentlemen have not seen fit to be in attendance at a Council Meeting this year. When the recently revised Constitution was first promulgated Club Presidents had been deprived of their vote and Branch position. It was only in response to the general protest from the Clubs that the office was restored. We trust that these gentlemen can, in the future, give more support to the Branch in this fashion since on many occasions the opinion of the Club president, who can speak with the authority of his Club, would be of invaluable assistance.

The monthly circular has continued to be the main organ of the Branch, but again as in previous seasons we suggest that Clubs act upon their delegates' reports since on many occasions the circular is received late for Club meetings.

#### BRANCH EXECUTIVE

The Executive has continued wherever practical to meet on the first Monday of each week and an enormous number of matters of a routine or pressing nature have been dealt with and finalised.

Clubs should bear in mind that a majority of matters presented to the Council have originally been tabled to the Executive and in some cases urgent action taken.

Our thanks and appreciation are extended to all those Officers and Delegates who by their regular attendance have assisted in bringing the Season to a successful conclusion.

It became obvious during the winter months that a weekly meeting was not completely necessary and it is possible that in the future some amendment may be introduced to have this body meet on a fortnightly basis particularly during the winter months.

#### RESCUES

A comparison of rescue figures for the past three (3) years has been prepared, and is set out as below. Particular note should be made that these figures are taken from Clubs at present constituting the Sydney Branch and are not for the Manly-Warringah Clubs, which were previously affiliated with this area.

The fluctuation of these figures between the Seasons 1958/59, 1959/60 and 1960/61 show a great variance but when taken in comparison with Seasons back to 1955/56 and onwards a general pattern is established whereby rescue figures constantly vary.

Many explanations can be brought forward amongst which should be taken into account the nature of the Season itself and the weather conditions. However, one is clearly able to establish the fact that our Patrols have been most vigilant in their duties and to these Patrolling Members, who are only too often the unsung heroes of the Association, we extend our sincere appreciation of their attention to the fundamental aim of this movement, and their devotion to our motto of "Vigilance and Service".

Once again it is our proud boast that no lives have been lost on a Sydney beach whilst our Patrols have been on duty.

#### **MEMBERSHIP**

In the 11th Annual Report for the Season 1959/60 I drew attention to the position of the Membership of our Clubs, and raised the question of whether the Membership figures should not be showing a more noticeable increase in comparison to our increase of population and the popularity of surfing itself.

A summary of figures for the past two Seasons is set out as under and one can readily see that this position has not corrected itself and, indeed has shown a drop of some approximate six hundred (600) from last year. The figures for the current Season are also some approximate two hundred (200) lower than the Season 1958/59 and this trend will have to receive the most urgent attention of our Association and corrective steps taken.

The Sydney Branch Council has expressed its concern to the State Centre that the formation of purely Board Riding Clubs and to a lesser extent Water Skiing has made inroads into our membership and the State Centre has established a committee to investigate the matter and bring down the fullest possible report upon the accuracy of such statements and also suggestions of corrective action.

A careful study of Annual Report Schedules over the past years will bring to light a pattern that many of the Clubs in the inner City area are gradually declining in membership, whilst those Clubs that are established in fast developing areas are on the upward trend. The most obvious example of this possibly in N.S.W. would be the Cronulla district where the three (3) Clubs in that area, i.e., Cronulla, North Cronulla and Wanda, show excellent membership figures and also their awards gained have been consistently high over recent years.

Individual reports were given to Club Gear Stewards or representative of the Councils and Shires at the time of inspection. Copies were also supplied to District Supervisors so that they may re-check any equipment found to be faulty.

#### FINANCE

The financial affairs of this Branch have been ably co-ordinated by Mr. Barry Pitt, Treasurer, and Mr. George Lindsay, his assistant.

Mr. Pitt occupies positions in the Dee Why S.L.S.C. as Secretary and Treasurer and the personal effort that must be required to maintain his association with this Branch is greatly appreciated.

Mr. Lindsay, who is a Life Member, has been long associated with the financial position and has served under many great Treasurers.

His very complete handling of the duties of Branch Purchasing Officer has throughout the years greatly assisted our Clubs and ensured a continuous and ready supply of essential equipment.

Both these gentlemen signified to the August Council meeting of their intention of not seeking re-election and their decision has been accepted with regret.

#### MISCONDUCT

During the Season the Association on a Branch, State and National level was constantly beset by problems of alleged misconduct by members of our Clubs.

The State Judiciary Committee had not concluded their findings from the Australian Championships in 1960 when they were summoned together to deal with a number of charges of misconduct arising from the 1961 State Championships at Tathra.

A number of Clubs were cited and subsequently one Club at least was refused permission to attend the Australian Championships in Moana. The Branch Council directed that a meeting of all Team Managers of Sydney Branch Clubs should be held prior to the Australian Championships and this meeting was widely attended.

Duties of managers were made clear to them and also many hints and advice upon management and conduct of their teams was given by the officers present.

The meeting recorded a number of recommendations to the Council one of which is that "when Teams from this Branch are travelling a long distance to a State Carnival or, Interstate to Australian Championships that the Branch should nominate a General Manager".

This problem of misconduct is one that is not new to us but we must realise that the Association is now more in the public eye than ever before and our prestige and standing must be upheld.

On the other hand the Association has a very real problem in distinguishing between complaints that are made from a vindicative or irresponsible nature against those which are bona fide. On more than one occasion this Season allegations that could have lead to disciplinary action were followed through and found to be baseless.

The Association should be as aware of its responsibility and loyalty to our members as the Clubs themselves should be as aware of our standing in the community.

#### LIFE SAVERS' WEEK PROCESSION

The main function of the Lifesavers' Week again this Season was the procession, which was held on Saturday, 26th November, 1960.


Though the secretarial work is now carried out at Mr. Staunton's private office with financial assistance, the Branch has benefited by a reduction in its overall expenditure.
