Gentlemen,

On behalf of your Hon. Superintendant John Dewey, and the Officers of the Sydney Branch Board of Surf Life Saving Control, I have pleasure in submitting to, for your consideration and adoption, the 29th Annual Report of our Organisation. It endeavours to account and record the activities of the Board over the past 1977-78 season.

Having completed the inaugural twelve months' operation of the Board under the new structure as "Board of Surf Life Saving Control" your Executive Committee can look back over the shoulder and be rightly proud of a progressive year of trial and advancement. The operation of the Board under our new banner and structure has been an educational experience like starting anew, casting a weathered mode of ways and means aside and striding cautiously into an advanced system of administration which has not been tried before. Like the profit chart of company in uncertain times our line graph has steadily climbed with but a few dips. The Board of Surf Life Saving Control has been a success which is being closely watched by many other sectors of our Association. We have had, and indeed still have a few, teething problems, but a strong executive committee combined with the support of our members has carried our concept into fact. Much remains to be done to cement our advancement and correct our numbered faults but if any section of our Association has the power, experience, knowledge and dedication to continue our restructure programme, Sydney Branch is the One.

A keen man at the helm once again this year was John Dewey as our Hon. Superintendant. John had a leading hand in the implementation and continued programming of our re-structure and is to be congratulated on a fine record through a very challenging year. John's able Deputy was John May who was our Deputy Superintendant for a second term. Wearing the new cap of Examination and Instruction Supervisor last season was Solly Stephens who accomplished a mammoth workload in this portfolio and was instrumental in the establishment of an active education plan which was instituted with reasonably encouraging results in the pursuit of bringing our members up to date with the latest techniques and requirements of our rescue network. These three men were all fortunate in having a competent band behind them to the aim of getting to the man on the beach. To District Supervisors Frank Osborne, Trevor Elliott, Dave Popplewell, and Kevin Andrews we cast a vote of thanks and congratulations.

With the integration of our Emergency Services Network into the Board of Control we can be thankful to Alan Morris, Harry Brown, Ian Badham, John Wardall and Paul Parsons who all worked together to abolish that wall which has seemed to separate beach patrols from mobile services in recent

years. They can be pleased with an increased awareness which seems to have precipitated from the man on the beach towards emergency services. Elsewhere, on the plus side, we can record the continued success of our Advanced Resuscitation Panel of Instructors and Examiners who have once again had a fruitful year through dedication to a considerable task. Gratefully, we can report a rather substantial membership boost.

On the other side, the season was marred by a few characteristics including a slow start to the season where attendance rates at examinations and 'compulsory' re-education briefings left something to be desired. Pleasingly this fault and apathy in a small area diminished to a smaller and smaller percentage as the season advanced. One of our greatest problems last year was making people aware of our re-structure and the implications of same. As usual, the majority of our ranks are slow to change and sometimes we find that the individual is merely interested in what change will do to him alone rather than joining the changing scene enthusiastically and 'spreading the word'. Things are gradually moving though and all pointers say it will be a further consolidation for the establishment of the Sydney Branch Board of Surf Life Saving Control in '78-'79. We are well and truly close to the right formula and with the support of every member of the board, next season will cement the system we are proving to the rest of the Association.

EXAMINATION AND INSTRUCTION SUPERINTENDENT'S REPORT.

The past season under the new Board structure included instruction as one of the duties of the Examination Supervisor. Attempts have been made to improve our standards by instructional field days and lecture nights. It seems that a number of members that have served the Association for some time don't consider that they have to keep up to date with the current procedures which means that candidates are the ones that suffer. It could be a different story in the coming season with the new manual and methods having to be taught to both the candidates and the Board. I personally consider that any member that doesn't present himself on Instructional days should have his membership reviewed.

After taking on the position in August last year, I undertook to conduct four field days - one in each of the districts for Instructors, Chief Instructors, Board members and interested persons. A squad from Wanda S.L.S.C., was used for demonstrations, to whom I offer my thanks, however over the four days the total attendance was 34 persons, of these 12 clubs were represented by their Chief Instructor or his substitute and only 16 Board members presented themselves. These days were followed up with literature appertaining to Emergency Service Areas, I.R.B. signals and Board Rescue procedures, as it would be expected that these play such a large part in our methods that candidates should be taught and examined on them.

Lecture nights were arranged throughout the season for Board members and interested persons, the attendance of younger members was very pleasing. The first of these was by Warren Rennie on "Methods of Training and Examining". Later in the season, Dr. Ian Mackie presented a lecture on the changes in E.A.R. and E.C.C. This was followed by a lecture and discussion by myself to all probationary members on the conduct and procedure of Examinations. Dr. Sue Rowley, one of our Medical Directors along with Peter Mc Cormack (Wales Rescue Helicopter) and John Park of the Red Cross formed as a team to present a talk upon aspects of first aid and care of patients in emergency situations.

To the above lecturers and their assistants please accept my sincere thanks for giving your services to assist in the improvement of our methods. It is hoped that more members will take an interest in such lectures that may be arranged in the future and in turn pass this new knowledge back to the man on the beach. If there are any lectures which you might feel could be beneficial, then the Board would be only too pleased to arrange the necessary speakers to suit.

Instruction was also given in Advanced Resuscitation in various Clubs in No.3 & 4 Districts as well as Caringbah Community Clinic. I wish to thank those who assisted in this instruction especially Frank Osborne who was the Co-Ordinator in both the Instruction and Examination of this award.

Organisations outside the Association have also been given instruction for various awards by Clubs and members of the Board. Our thanks go to those members for their efforts in this field and also for their promotion of our ideals

Without instruction there would be no examinations and as can be seen by the figures below, the Board has been very active throughout the season

in the examination field.

Dealing first of all with Instrcutors, Bronze Medallion and Qualifying Certificate Examinations, sixty-nine examiners were involved in these averaging four exams each. There were I3I squads squads examined and on most occasions there were two members appointed per squad. Records show that 279 appointments in all were made. Of these, on 55 occasions, members failed to meet their obligations. Altogether this means that at least 900 man hours was spent on the beach examining these squads. There were nine squads failed for various reasons, these being successful on re-examination.

Unaccountable hours were spent in Advanced Resuscitation Training and Examinations. This load has been spread with the acceptance of Examiners from No.3 & 4 Districts as well as those already carrying out the work at the Caringbah Community Clinic. To the following members I offer my thanks for accepting this extra task. Frank Osborne (In Charge), Dave Medlin, Bob Ford, Mick De Luca, Laurie Love, Bruce Breadner, Trevor Elliott, Ern Stephens, Keith Grima, Peter Carney, Eric Guaja, Carl Melvey and Tony Pashalis. The standard of this award has been kept high and up to date with the training and supervision by Dr.Ian Mackie, and on occasions, Dr. Peter Malouf. To these people we offer our thanks for the time they devote to the movement in our interest.

In Conclusion, the Examination Scene has been somewhat easier by the increase in membership and it is hoped that this continues, however we must look at the standards, not necessarily the numbers. When one comes to realise that members training for awards spent about 64 hours each, plus time studying there manuals, it is only fair that all members of the Board take the opportunity to keep up with the standards as the new members joining the movement will be more versatile than those of the past in training with modern techniques.

Thanks one and all for your assistance throughout the]977-78 season and let's see next season be one of improvement and consolidation.

REPORT UPON THE CO-ORDINATION OF THE ADVANCED RESUSCITATION COURSES
IN SYDNEY.

During the past year, 168 Advanced Resuscitation Certificates have been awarded in the Sydney Branch and 42 members have been re-assessed for their Advanced Resuscitation Certificate and are now current for another two years showing that about one quarter of those who gain Advanced Resuscitation Certificate are re-assessed.

Also during the year, four resuscitation courses were run for members of the Intensive Therapy Courses of the Health Commission of NSW together with six special revision nights for members of the Wales Helicopter Rescue Service.

We are receiving more interest from outside organisations in the Surf Life Saving Advanced Resuscitation Certificate, particularly from Ambulance officers, St Johns Ambulance Service, Electricity Commission, MSW&DB, nurses in industry, pool supervisors and now a big influx of the Bush Fire Brigade.

Additional duties taken on by the Resuscitation Team were a demonstration to 70 girl guides at Tara Guide Camp at the request of the State president.

The training and examination of 55 girls in resuscitation at Sydney Girls High School and the training and examination of a number of boys in fifth and sixth class for their resuscitation certificate.

These were to try out the syllabus for the junior resuscitation handbook by Dr Ian Mackie.

A special Think Tank of six successive Wednesday nights went into the problems of teaching Advanced Resuscitation.

Dr Ian Mackie, "Solly" Stephens, Trevor Elliott, Dave Medlin, Mick De Lua, Bob Ford, Tony Pashalis, Eric Gauja, Peter Carney, Carl Melvey, Laurie Love and myself making up the attendance.

From this Think Tank it was decided to teach instructors to instruct the Advanced Resuscitation Certificate in the clubs, arrange the examination and thus the resuscitation panel would be able to spend more time on revision and research, particularly on methods of teaching teachers to teach.

One course for instructors was held and nine people were trained.

The people from No 3 and 4 Districts seem to appreciate this facility, and a number of members have now been examined there.

A party went to Bega last June at the request of the State Superintendent Ike Moseley to instruct and examine members of the Far South Coast Branch in their Advanced Resuscitation Certificate and the re-assessment of members who have gained the award. In this endeavour I was assisted by Dave Medlin and Laurie Love, however at the last minute Dr Peter Malouf was not able to go so I had to spend most of the time, whenever a doctor was able to come in, to break off and explain our methods of instruction showing slides and trying to gain a Medical Officer for the Far South Coast Branch. I am pleased to report that this venture was successful in getting several doctors to form a medical panel there.

I would like to advise that during the year there were 65 nights or days held and I am indebted to Dr Ian Mackie, Dr Peter Malouf, "Solly" Stephens

Trevor Elliott, Mick De Luca, Dave Medlin, Bob Ford and Laurie Love for their continued support on most of these occasions as instructors and examiners. Also, to Tony Pashalis, Eric Gauja, Peter Carney and Carl Melvey for their assistance in instructing and examining in the No 3 and 4 Districts.

MOBILE SERVICES CO-ORDINATOR'S REPORT

During the past season bad luck has struck all of the Jet Rescue Boats in the Branch, none of which was due to the personnel in the craft. No 4 District boat since its delivery has suffered a number of faults. At the State championships the boat suffered major engine failure. After inspection it was found that excessive wear throughout the engine had caused the failure. Reports from the NRMA, Ford Motor Co and myself have been sent to the Waverley Council on these faults. It has been recommended that a new motor be fitted into the boat. At this time a meeting is to be held with Council with regard to this matter.

No 3 District boat has been running well except for a motor failure half way through the season. Due to this failure the boat was out of the water for only one weekend during the season. This is the fourth year that the boat has been in operation and Randwick Council are subsidising the purchase of a new boat for next season, pleasing to note that the new boatshed at Malabar should be operational by next season.

The No 2 District boat has suffered its share of problems, as have the other two boats, but is back in operation again.

The No 2 and No 4 District boats were fuelled by TOTAL, while No 3 District boat was fuelled by CALTEX. It is hoped that these companies will again subsidise the fuel in this coming season.

The Sydney Branch JRB panel annual meeting was held on 24th July with the following officers being elected - JRB Supervisor J. Fotopolos; Secretary S. Stone; JRB Inspector R Green.

The five-metre Avon inflatable rigid hull boat is underway and progressive reports will be forthcoming to each Board of Control meeting.

In conclusion, I would like to thank all the officers of the Branch and sub-committees for their assistance and guidance during the past season.

It is pleasing to record the training and progress of many clubs who have just acquired I.R.B.s. Their winter training programmes have provided their Club with a nucleus of qualified drivers who can impart instruction and thus further expand their I.R.B. team.

In Clubs where I.R.B.s are firmly established they are effecting between 20% and 33% of all rescues performed and are proving their worth as an important tool in life saving.

Like all other equipment that relies on mechanical contrivances, electricity and petrol to operate, they can fail at the most inopportune time and therefore maintenance by Club I.R.B. personnel is extremely important.

A Sydney Branch Outboard Motor Training School was conducted at Johnson Outboard Marine during the summer.

The one day school, (Wednesday January 25th, 1978) was well attended and gave members advanced training sufficient for them to :

- (a) Carry out grease and oil changes
- (b) Remove and repair gear box assembly
- (c) Remove and repair water pump
- (d) Change motor bracket assembly
- (e) Clean and adjust carburettor
- (f) Tune motor

We are indeed grateful to Outboard Marine for providing the facility and personnel for this highly successful course.

The Branch was honoured at the venue for the Johnson Zodiac N.S.W. Advanced I.R.B. Training School held at North Cronulla on Saturday 27th and Sunday 28th, 1978, and was attended by members from Garie, Cronulla, North Cronulla, Elouera, Wanda, Maroubra, Coogee and Bondi.

The school was an outstanding success and gave invaluable information in driving and rescue techniques, and boat and motor maintenance to those who attended. The school also set a standard for the I.R.B. Instructor's and Examiner's Certificates to be introduced at the start of next season.

We also record our appreciation to Total Australia for providing fuel to those clubs fortunate enough to gain the Total Fuel Subsidy.

During the past season, a total of 20 I.R.B. Driver's Medallions and 10 I.R.B. Crewman's Certificates were gained.

It is important that each Club with an I.R.B. appoints an I.R.B. Captain for the forthcoming season to ensure that proper progress is made in co-ordinating their I.R.B. into the Club's patrol activities.

With more drivers, the I.R.B. will become more effective with less burden on a few individuals.

Clubs must conduct a continual training programme to introduce new members into I.R.B. activities and to cater for drop-outs.

On behalf of the Board of Control I wish every Club success in their I.R.B. operations in the forthcoming season.

WALES HELICOPTER RESCUE SERVICE

In its fifth season of operation over 1977-78, Sydney's Wales Helicopter Rescue Service responded to 208 calls for assistance.

These were achieved over the full season with the helicopter crew forming the Branch's only operational unit to again be on duty every weekend over the full 12 months.

Rescues ranging from surf and cliff areas, to rendering aid to people injured in isolated areas, beaches and on boats, to flying injured patients to hospitals in Sydney from as far afield as Goulburn, Katoomba and Newcastle, to assisting with bush fire control and a wide range of search and support missions. The range demonstrated the wide community role achieved by this Sydney Branch facility.

Co-operation was even further improved with other civil emergency groups during the year, with the helicopter now being fitted with ambulance in addition to police radios.

The SLSA switch to UHF radio equipment for Helicopter and Jet Boats has greatly improved communications, and this should be reflected in even better rescue co-ordination this coming season.

RADIO OFFICER'S REPORT.

I have much pleasure in submitting the following report on the Branch Emergency Services Radio Network, as it was a season of much activity and general advancement.

Sydney Branch now has a Team of Operators who are mature, experienced in rescue control, show attention to detail and a dedication that the Branch can be very proud of indeed.

The Group, arrived at following a determined culling out operation, totals 18 persons and includes our first lady operator Miss Carol Wilson from Sydney Branch Office who has been most efficient and conscientious.

There were four occasions during the season when the Rostered Operator failed to arrive for duty, requiring the use of standins.

Whilst this situation is regretted it is a vast improvement over past years, and hopefully, can be completely eliminated now that the team has a new operations room and facilities.

The Operations Room has been made available, and constructed at no cost to the Branch, by the Board of Directors of the Maroubra Seals Club Ltd., and is situated on the upper floor level, adjacent to the pool, sauna, and gymnasium, and has a complete view of the Maroubra Beach area. Our operators should now be, not only the best situated in the state, but also the fittest.

A noticeable improvement in A.M. Radio performance is also anticipated, with the antennawow at an elevation of some 50 metres.

On Saturday, 11th March 1978, after many delays and much frustration, extending throughout the season, our base and branch power boats had their U.H.F. Radio System finally installed and operational.

Although the season was virtually at an end, all crew members and operators expressed total satisfaction with the system's range, clarity, and interference free performance. Already two of the more progressive Clubs have shown interest in purchasing their own U.H.F. sets.

On the subject of progressive clubs, I am amazed that some clubs' attitude towards radio still appears to be one of - "It's a flash in the pan, it won't last", to the extent that they still do not have a radio room at all, and one has not had a radio officer elected for last season at least.

Bearing in mind the old saying about 'Strong as the weakest Link', we are not too strong at all in this area.

Once again, repairs were quickly and capably done by Nat Cohen at Bondi who said on quite a few occasions that the repairs were required only because of neglect or stupidity, and cost some clubs and power boat groups unnecessary time and expense.

During the season, the branch kindly allocated \$300, to assist Harry Brown and his club to develop a radio suitable for use in IRB's. It is pleasing to report that the project has turned out very successful through Harry's efforts, and that a waterproof radio should be available to IRB's for the forthcoming season.

The radio division received a great deal of help from many areas during

the year, and I would like to record my appreciation to the following individuals and companies, for their efforts to assist the clubs and the Branch:
