The Surf Life Saving Association of Australia is celebrating its 75th Anniversary so this foreword provides an excellent opportunity to record a simple but sincere token of appreciation to the Examining Board for their contribution and dedication for this and past seasons.

From the humble beginnings in 1907 when the New South Wales Surf Bathing Association was formed and a set of objectives were accepted, Officials have continued to maintain and improve Lifesaving standards.

Undaunted by the early challenges by 1910 the Association had formulated a Rescue and Revival Drill, fashioned fairly practical gear and derived standards for entry for Lifesavers into the Association.

Progressive development of the resuscitation systems of Schafer, Eve, Holger-Nielson and mouth to mouth were to involve many generations of Board Members in countless hours of instruction and examination.

Modern trends have now involved Examiners as specialists, advisers or panelists in the fields of Mobile Services, Communications, Lifesaving Education, Community Lecturing and Medical Research - a large slice of the action for a voluntary organisation in today's world.

Moreso than ever before Clubs must realise a responsibility to sponsor this vital area of Branch Administration and actively encourage their Members to participate. An efficient and adequately manned Board is essential for the future progress of our Branch.

In conclusion may I on behalf of Branch Officers and Clubs extend sincere congratulations to all Board Members on their achievements and to the hardworking Executive of the Board of Control, under the leadership of Honorary Superintendent, Trevor Elliott, on a job very well done and to Board Secretary, Steve Strange, on once again producing a fine Report.

Board Run Competitions

The annual Gear Inspection was held September 27 and 28 in the No.2 and 3 Districts and October 11 in the No. 1 District. The report from the committee, headed by Nick Dixon, commented on the general improvement in the condition of Clubs' gear. However, there was concern expressed that 11 surfboats were not put up for inspection when the Panel visited each Club. In determining the winner of the "Don Lucas Trophy", the Committee expressed the view that Clubs with gear still to be inspected could not win the competition. After lengthy deliberation, in view of the generally high standard set by Clubs, Cronulla was declared the winner. I would congratulate Cronulla Club on this achievement and I would also take the opportunity to thank Arthur White who kindly organised and acted as driver of the bus that transported the Committee through the No. 3 and 4 Districts.

After a lapse of many years, the Board conducted an updated version of a Branch Patrol Competition which was held at South Maroubra on April 18. Nominated patrols attended on the day, established normal patrols on the beach and participated in nominated rescue sequences. Patrol attendance, knowledge of the Instruction and Examination Manual and general patrol behaviour on the day among other requirements were taken into consideration by the judging panel. Of the 15 Clubs in the Branch, 6 nominated for the competition. North Cronulla, Wanda, South Maroubra, Maroubra, Coogee and Bondi all nominated patrols. All proved extremely competent which left the panel a hard task in deciding the winner. Our congratulations to Wanda Club and Patrol Captain Ernie Stephens who were successful on the day.

I would like to thank Karl Solomonson and his committee who established the background for the competition and John May and his committee who developed the competition further and conducted the event on the day. I hope all Clubs in the Branch field patrols in the competition next season now they have had a chance to see the inaugural event.

For the first time the Board conducted a United Permanent Branch Marchpast Competition, seperate from the State-run event. Three rounds of the competition were held. The first round at North Cronulla carnival, then North Bondi and Elouera. It was rather disappointing to see only four regular teams march in the competition this year. I congratulate Elouera on winning the competition, with Burning Palms, second; Tamarama, third, and North Cronulla, fourth. It should be noted also, that all these teams marched at all Sydney Branch Carnivals and attended the State and Australian Championships, with North Cronulla gaining third place at the State and second place at the Australian Championships.

The good relationships built up over many years between the Board and the Clubs of the Branch have continued during this past season. I would thank Club Management Committees for their co-operation and the implementation of Board decisions and look forward to its continuation next season. In part-, icular, I would personally thank the management of the Maroubra Club. They have hosted all full meetings of the Board this season and as well the Foard has held a number of special meetings at their Club.

Membership

Membership of the Board was marginally reduced at the commencement of the season following a review of members attitudes to Board undertakings and their participation in activities during the 1980-81 season. However, with new membership nominations received, and those gaining specialist Examiner Awards, we were able to maintain and even surpass our numerical strength as compared to last season.

The year under review was especially good in terms of probationery memberships approved. A total of 22 new members joined our ranks as probationery members. Eight have since gained their Examiners Certificate and I would welcome Stewart Baily, Graham Bruce, Ron Camilleri, Bruce Fraser, Ron Hammond, Peter Murphy, Rod Silcock and Graham Smith to the Board. Fourteen probationery members are still to complete their formal examination and I welcome them also: Craig Bissell, Peter Davies, John Hammond, John Lloyd, Michael Martin, Grant McMah, John Osmond, Kym Pennell, Jim Poulos, John Shaw, Alfred Smith, Brad Taylor and Bruce Tually. I would especially welcome the Board's first female member, Marion Lucas of Wanda, who has joined us and who is proving very capable on the examination side of Board activities.

As mentioned earlier, a review of membership was undertaken and it is anticipated a further review will be made of members' contributions during this past season. A list will be submitted to the first Full Meeting of the Board and those members in default will be asked to indicate their intentions for the 1981-82 season.

there will have to be serious consideration given to the timetable for each carnival in order that our Members and the competitors are not still on the beach conducting events after 4.30 p.m.

In November a field day was arranged to introduce new judges to the R & R and Marchpast events. It was hoped that a reasonably competent panel of judges would be obtained from this day to run the competition during the season. There was a dissapointing roll-up of Members, but for those who did attend, a great deal of benefit was obtained, especially in the Marchpast section where even seasoned judges learnt something new. I would like to especially thank the Wanda R & R team for their patience and understanding of the Board's objective on this day and also to the Marchpast coaches who were in attendance.

In February this year, Bernie Kelly organised a New Members' night at Maroubra. The evening was well attended by Probationery Members and formal examinations were held for those members eligible to join the Board as Full Members. Members of the Executive gave some insight to the internal workings of the Board and Branch President, Bill Marshall told those present that all who join the Board would, in the long term, gain immeasurable satisfaction for themselves and bring new knowledge to their own Clubs.

The emergency services within the Branch again performed outstandingly. The Wales Helicopter Rescue Service completed nearly 400 missions, bringing the total since the inception of the Service to 2,037. JRB2 in the Sutherland District maintained regular patrols, even though they were extremely hampered by increasing running costs and lack of adequate finance. Clubs within this District will have to seriously rethink their attitudes towards providing the necessary finance to enable this rescue facility to fully maintain viable patrols in the area.

JRB3 has again this year continued to provide surveillance in the No. 3 and No. 4 Districts. A new craft has been order and will be operating at the start of this coming season. It appears at this stage, there will not be a permanent JRB4 operating, but active negotiations are continuing at District Executive level for a combined funding for the JRB3 operation.

Meetings have been held of the JRB Panel and since the resignation of Rae Sorenson for health reasons from the position of JRB Supervisor, members of each JRB group have been attending Executive Meetings to report their activities. A start has been made by the Panel to formulating a whole new policy on the operations of JRB's within the Branch. JRB Groups are aware of the serious situation of not having a JRB Supervisor to represent them at Branch level and have indicated they will elect a Supervisor at their Annual General Meeting to be held this month.

During the year, further UHF radio tests were conducted in the No. 1 District both by our Radio Officer, John Wardall and by NSW State Centre. Results are very encouraging and all Clubs are able to contact Illawarra Furf Rescue in cases of emergency where the Wales Helicopter Rescue Service is needed to treat and evacuate patients. In addition, towards the end of the season, Burning Palms was able to contact Sydney Surf direct using the Branch's spare UHF radio. Negotiations are currently underway with State Centre and the Wales Helicopter Rescue Service with a view to installing a repeater radio system which will enable Clubs in the District direct access to emergency services 24 hours a day. As can be seen, the total number of members who are really making the Board function properly is 95, compared to last season's total of 104. This is a serious situation especially when considered that of this total 95, there are 22 new or probationery members contributing to the workload. Members must give careful consideration to their status within the Board and be prepared to put in a worthwhile contribution to our functioning during the year, or be prepared to resign. It is a waste of time and Branch money to continually maintain membership of the Board if you are not prepared to make a contribution.

These figures for members who are working for the Board are further emphasised in the following section, dealing with Meetings.

Note 1 Mick Berger was granted Leave of Absence at the November Full Meeting of the Board. Jim Connolly has been attending meetings as Assistant District Supervisor since March, 1982.

Five Full Meetings of the Board have been held during the past year. The first, was combined with the Board Seminar and was held on August 29, 1981. The meeting endorsed some of the recommendations from the Seminar and a review of membership as compiled by the Executive was submitted for ratification.

The second meeting, held at Maroubra Club was attended by 34 members. A report from the Seminar Committee was adopted and recommendations were endorsed. The Patrol Competition Committee was elected and competition matters were discussed, particularly clashes of carnival dates.

The third meeting had an attendance of 40 members. It dealt with reports of Board Officers and further recommendations from the Board Seminar were adopted. A question and answer session was incorporated in general business. The meeting was held November 25, 1981.

The fourth meeting, held February 24, 1982 had 44 members in attendance, the most members attending a meeting for 3 years. Reports of Officers were presented and lengthy discussion on examination techniques and responsibilities

of Examiners during candidate belt swims took place. The State Superintendent, and Deputy President of State Centre, John Dewey and John Vaughan, respectively talked on the lead-up preparations for the New South Wales State Championships.

The fifth meeting held April 28,1982 was attended by 37 members. General discussion on the Australian Championships at Moana Beach, South Australia were held and a report of the Sydney Boat Panel regarding the shifting of buoys for the surf boat final was endorsed. Mr. Perc Russo from the Cumberland College of Health Sciences presented a lecture on the health and fitness of members which was illustrated by slides.

Attendance at full meetings has remained fairly constant (1980-81, 37, 33, 39 and 24), but there is room for improvement. Only four full meetings are normally held during a season and they provide valuable information both for members and more importantly give the Executive feed-back on Board policies.

I would remind Members that the Constitution requires you to vacate your seat on the Board if you absent yourself from two consecutive general meetings of the Board in one season without reasonable written excuse.

EXAMINATION AND INSTRUCTION SUPERVISOR'S REPORT

The seasons' Award totals were down on the previous year's figure. However, even with the slump in totals, the outstanding efforts of 3 Clubs must be acknowledged and congratulated. North Cronulla with 179 active awards and both Elouera and South Maroubra with over 100 awards. These 3 clubs alone accounted for 35% of the total Branch awards.

There are some points from the following Award Tables that I believe are worth highlighting and an improvement made next season:

- no JRB Crewmen's Certificates were awarded
- only 4 JRB Driver's Certificates were gained
- although there were 59 Radio Operator's Certificates awarded Clubs need to improve on this figure
 - Bronze Medallion awards are down 36 on last seasons total 414.

There are two other matters which disturbed me this year. The inactivity of the ARC Panel and the alarming lack of Examiners in the No.4 District. However, with persistence I believe both these matters can be corrected during the coming season.

I would like to thank all those members, who, without their assistance and experience, my job would have been impossible. In particular I would thank Ernie Stephens and the District Supervisors for their co-operation. To Carl Melvey, Neil Miller and Greg Hewett, my personal thanks for the number of examinations you have undertaken, especially on so many occasions with such little notice. CARNIVAL AND COMPETITION SUPERVISORS' REPORT

We are approaching a new season which will involve a short and very busy schedule. The Referees, Mick Berger, Nick Dixon, Jim Connolly, Ron Howells, John Dewey and Trevor Elliott and the appointed Officials gave their full support and co-operation which went a long way to making all carnivals so successful. It was however, unfortunate that the South Maroubra Carnival had to be cancelled at the last minute due to pollution problems caused by a Water Board strike.

Again, a meeting of all Club carnival organisers was held early in the season and from comments received Carnival Referees have been involved with each club's respective carnival, ensuring that the competitive side ran smoothly.

I would like to thank all Board Members who officiated at carnivals during the past season. I would make special mention of our ladies, Mary Andrews Ann Ainsworth, Gloria Howells and Merle Sargeant for their invaluable assistance throughout the year. I know how many members appreciate your efforts and from me ladies, my personal thanks to you all.

To John Dewey, who has tried to bestow on me some of his great wisdom and as Branch Gear Steward, along with Arthur White and Bill Singleton, thank you for maintaining our equipment in such good condition. Harry Brown and Graham Bruce and the other IRB crews, well we now cannot do without you at carnivals. To Perce Ainsworth, thank you again for looking after the Board's carnival stationery, watches and starting guns. Your attention and time is very much appreciated.

I look forward to an exciting season coming and in closing, my thanks for their co-operation to all competitors and to our unofficial official Peter Doolan for his tremendous help in the craft area.

WALES HELICOPTER RESCUE SERVICE

The Service is now completing its ninth season of duty in what has proved the busiest on record. Over the SLSA statistical season, the Wales Helicopter Rescue Service in Sydney completed 397 seperate missions comprising:-

> 30 people rescued 172 people given medical assistance 195 search and support missions.

Since its inception the Service has now completed 2,037 missions.

A significant improvement to quick response to emergency calls came during the season with an increase in budget funds last October. Since then the Service has engaged a second pilot and has maintained a double shift at weekends and on public holidays.

This has meant a duty crew comprising pilot, doctor and rescue crewman on duty from 6.00 a.m. to 10.00 p.m. every weekend and public holiday. In addition the mid-week period is covered from 8.00 a.m. to 5.00 p.m. (6.00 p.m. daylight saving) with the Friday evening period covered until 7.00 p.m.

Outside these hours, the Service has been on call to respond to emergencies on a 24 hour basis. To achieve out-of-hours co-ordination the Service has an emergency telephone number which is diverted to a duty officer when the office is not staffed.

The Wales Helicopter has always held a primary function of being a rescue, search and medical back up to Surf Club patrols and mobiles. Beyond that, the Service provides community support, in particular in liaison with Police and Ambulance.

The Service's charter is "To provide a search, rescue and medical support service for the community - without cost or obligation when life is threatened - in co-operation with emergency authorities".

This showed with rescues from bush areas, boats at sea and in rivers, plus being called to search for missing bushwalkers and boats as well as transferring seriously ill patients from outlying hospitals to major treatment centres.

It was rewarding to note the saving of life when fishermen were reported swept from rocks. Helicopter crews rescued some five fishermen from this situation - two after they had spent almost an hour in the heavy seas off Royal National Park clinging to an esky.

The value of having support of a crew doctor showed in many missions where vital "intensive care" treatment was supplied in the field before a patient was taken to hospital. Where Lifesavers need such support, such as in cases of immersion, exposure or cardiac arrest, the Helicopter provides competent support crews and supplies.

Provision of the Helicopter by the Surf Life Saving Association, Sydney Branch, again was made possible through sponsorship provided by:-

> Bank of New South Wales Radio 2UE Sydney Channel TEN Sydney.

Additional support came from the NSW Department of Sport and Recreation -

in particular with special funds to equip the aircraft with a 3.5 million candlepower Locator searchlight. Other support came from service clubs and from the Royal North Shore Hospital where the Helicopter is based.

It is anticipated that next season will be the last of duty for the current Bell Jet Ranger Helicopter, which has been chartered from Ferguson Helicopters since 1976. Provision of a more suitable helicopter which will allow the Service to more efficiently provide back-up support to a wide variety of situations. From records, the Sydney Helicopter carried out some 60% of all missions completed annually by the SLSA's 10 rescue helicopters.

The appreciation of all involved in providing the Wales Helicopter Rescue Service for the community is extended to Officers of the Board and Branch, Clubs, radio room operators and the various crews of jet and inshore rescue boats with which the helicopter has linked.

IRB SUPERVISOR'S REPORT

It is with a great deal of pride and pleasure that I record the activities of our Inflatable Rescue Boat Section during the past 12 months.

Thirteen of the Branch's 15 Clubs now operate IRB's. All Clubs participated in training programmes during the year and their individual efforts are reflected in the IRB Activities Schedule.

The inaugural IRB Education Training Panel Seminar held by State Centre at Cronulla on 10, 11 and 12 July, 1981 was conducted and the following Branch members were selected onto the NSW IRB Training Panel: B. Gardiner, D. Cooper, B. Kelly, E. Goldberg and H. Brown.

The National IRB Conference was held at North Cronulla on 4, 5 and 6 September, 1981 and the submissions from Sydney Branch were a significant contribution to the recommendations endorsed at the Conference.

Our IRB Inspectors carried out detailed inspections of all IRB's and motors during the annual Gear Inspection in September and it is pleasing to record that apart from some minor work all Clubs had their boats operational. IRB Examiners carried out several examinations and it is pleasing to record there were no failures. In fact, the standard of driving was quite high. Particular mention should be made of the examination carried out at Bronte with candidates from Bronte and North Bondi in attendance. The surf was at least 3 metres high and it is to the full credit of the two Club's Instructors that all candidates passed with flying colours.

The IRB's once again showed their ability as "the Association"s rescue tool of the eighties" in performing a total of 600 rescues which represents 25% of all rescues performed in the Branch. On many occasions they worked as a team with the No. 2 and No. 3 jet rescue boats. This form of search and rescue work is to be commended. Preventative actions, that is the moving of craft and people into their respective surfing areas was another important aspect of our surveillance work successfully accomplished.

All carnivals held in Sydney Branch utilised IRB's for laying of buoys and acting as the rescue boats and I would like to record my thanks particularly to Graham Bruce, Bill Singleton, Arthur White and Ron Day for their assistance and to all the IRB crews who participated. IRB competition is now an accepted part of our activities and the techniques of the drivers and crew have shown a great improvement due to this form of training under actual stress. An open IRB Carnival was successfully conducted at Maroubra in August and the Branch IRB Championships were contested at Cronulla Beach on Wednesday and Thursday, 10th and 11th February, 1982 as a twilight carnival. Era Club were the overall winners, however, all Clubs who participated enjoyed events and we are indeed grateful to Siebers Vogel Breads for their financial support.

The NSW IRB Championships were held at Soldiers Beach in 3 to 4 metre surf and the Sydney Branch contingent of drivers and crewmen performed extremely well.

The Total Company made a donation of \$350 which enabled the Branch to modify an old trailer as an IRB Gear Trailer and we are indeed grateful for the amount of work carried out by Bill Singleton in modifying the trailer and having it rustproofed.

Johnson - Outboard Marine conducted a motor training school on 13th February which was well attended and all members present learnt a great deal about preventative motor maintenance and we are indeed grateful for the continued support assistance of O.M.A.

In conclusion, I wish to extend my personal thanks and appreciation to all members who participated in our IRB activities during the past year. In particular, my IRB Inspectors and Examiners and the Club IRB Captains and Instructors for an outstanding job well done.

RADIO OFFICER'S REPORT

It is very pleasing to again be able to say that the Sydney Branch Base Radio was able to support the beach patrols to the fullest in protection and rescue of the bathing public.

The Radio Room was operational for the full patrol year of 68 days, staffed by 14 volunteers and despite the poor surfing weather early in the season, quite a number of rescues and searches were co-ordinated through Sydney Surf.

The total number of awards shows a slight increase over the previous season's figure of 66 and a significant number were of mature years and experience which will no doubt assist the participating clubs in maintaining their patrol efficiency. RESUSCITATION, RESEARCH, DEVELOPMENT, INSTRUCTION AND MEDICAL PANEL REPORT

BRANCH FIRST AID COMPETITION

The competition got off to a shakey start with the 2 teams entered at the Elouera carnival not being able to compete because of lack of Officials. They were however, given the opportunity to compete mid-week but only one competitor showed. At the Coogee Carnival, 6 teams were entered however no teams reported. I checked with team managers and no one knew they had been entered.

After quite a bit of chasing up, three teams were entered for the Branch Championships at Cronulla but only two teams reported on the day. The competition area was located south of North Cronulla and the accident involved a competitor at a carnival with a sucking chest wound, a cut over one eye, the patient was conscious but later lapsed into unconsciousness.

The result of the competition was Wanda 55% and Elouera 53%. After the competition concluded, the adjudicators advised the competitors where they had gone wrong and what would improve their performance. Both teams were nervous, unsure of what to expect and hampered by the bleak conditions and driving sand.

Wanda team became the Branch entrants in the State Competition and after one night tuition by muself on points to improve and a mornings coaching by John Bourne they gained a very creditable 2nd place (75.83%) to North Narrabeen (78.50%) who were the winners.

I recommend that to improve the competition standard, club members should be encouraged to undertake a basic first aid course. The Association should then formulate an advanced course in conjunction with outside organisations such as St. John's or Red Cross.

I would like to thank the adjudicators at the Branch Championships, Mrs. Shore, Nick Stepkavich and Linda Boyd for their help and assistance during the planning of the competition.

DEPUTY SUPERINTENDENT'S REPORT

The past season, 1981-82, has been a season of hard work and achievement for District Supervisors, Examination and Instruction and Carnival and Competition. At this point it appears that awards gained will reach close to last season's high figures, and carnival competition work is becoming more demanding as competitors are increasing, particularly in the areas of craft and 4 man R & R events. It is obvious that more attention will need to be paid to the practability of competition programmes.

Proficiency testing once again was slow off the mark. For the coming season it needs particular attention due to the early start of competition, commencing in October.

The introduction of a Patrol Competition due to the dedicated work of a small committee, has proved successful and will bring more prominence to bear on the important backbone of the club patrolman. Patrols throughout the season have been satisfactory with some minor exceptions. The problem of satisfactory surveillance patrols for the South Bondi area is in hand and the North Wanda situation is in the hands of No.2 District Executive.

The live-in seminar for Board Members held early last season was successful and produced a wealth of material which is still under investigation. For the coming season the Board of Control will be concentrating on field days for both examinations and examination procedure, and for judging and competition. These will be held prior to commencement of activities for the 1982-83 season. All Sydney Board of Control Members will have the opportunity to attend a State Centre Board of Examiners Conference weekend to be held in August.

The Board has been successful in recruiting 22 new members during the last season, all of whom will have passed their probationery period before the coming season. This, together with the planned field days and the State Conference should help to ease the work load of each Board Member.

District Supervisors, John May, David Popplewell, Jim Connolly (deputy) and Frank Osborne have supervised their Districts very effectually, even though they have had a very heavy season. A special appreciation is due to John May for his great assistance to the Clubs of No. 4 District, to David Popplewell for his persistence with the problems involving the Clovelly Club and to Jim Connolly who has so ably stood in for Mick Berger.

Most Clubs are realising the importance of the Branch Radio Network and are paying more attention to Radio Rooms. More radio operators' awards are being gained. Additional communication assistance for the No. 1 District seems to be still unavailable. This facility is a top priority. Burning Palms and Era Clubs have recently had their solar cells stolen, which is a further setback.

As usual, the Gear Inspection Committee carried out their duties very effectively. The Board Seminar Committee and Patrol Competition Investigation Committee also put in a great deal of work to reach a successful conclusion. The Board is appreciative of the assistance given on various matters by the 4 District Executive Committees during the season.

Once again, we must recognise the exceptional contribution to patrol work by the IRB crews who are ever increasing in numbers and who are so enthusiastically supported by Harry Brown with his thrust for development and training. The No. 3 District JRB has worked effectively and looks like incorporating the role of patrols for both No. 3 and 4 Districts again for the coming year. The No. 2 District JRB has patrolled efficiently despite their serious funding problems. The two districts have committed to appoint a JRB Supervisor to report regularly to the Board Executive, which will help all parties through improved communications.

It is encouraging to see the level of awards that have been gained for the season. This illustrates the work load borne by the various examiners and the enthusiastic approach by Bernie Kelly in his first year as Examination and Instruction Supervisor who is always striving for improved standards. The number of female candidates for awards is still maintaining its level. Their standard and keenness is generally very high which persists through their patrol work.

We must be ever conscious of those few officials who attend and work so hard at carnivals. The Board does not have enough members who contribute to competition which is so important for the motivation of Club members. We hope that the majority of the new Board members will assist during the coming season and repeat our annual plea to the Clubs to take a more responsible view to contributing by sponsoring members to join the Board to assist with the heavy competition programme.

Despite the shortage of Officials, carnivals were quite successfully carried out during the season. This was due in part to Ron Day who, despite the odds, always managed to provide a scant sufficiency of men to do the job.

My sincere appreciation to Trevor Elliott and Steve Strange for their full support and co-operation and to Bernie Kelly and Ron Day for their determined efforts during their initial year of Office.

CONCLUSION

All Members of the Board who have played a part in the success this season has brought can be justifiably pleased with themselves. It has indeed been a vey hectic year for all with proficiency tests, preliminary and final examinations and carnival work taking up so much of Members' leisure time.

Next season, 1982-83 has all the indications of being even more demanding on Members. Considerable efforts must be made by all Members if we are to maintain and surpass our present levels of activity.

A full schedule has been planned, commencing early in August with the State Examiners Conference. It is hoped that as many Members from our Board as possible will attend and at present the Branch Finance Committee is looking into ways of providing some assistance with registration costs. Four days have been allocated for both examination and carnival follow-ups to reinforce aspects of the State Conference. From the carnival field days, a full judging panel for both R & R and Marchpast will be formed.

This season will see one of the shortest and busiest carnival programmes for many years. Starting early in October with a craft carnival at Era and culminating with the Australian Championships at Clifton Beach, Tasmania on March 4, 5 and 6, 1983. With carnivals commencing early, it is expected that competitors will present themselves early for proficiency tests as will candidates for examinations. At this point, I would stress the need for all Members to return examination and carnival appointment forms as early as possible. Failure to do so will necessitate rostering for examinations and exclusion from carnival appointments.

An incentive scheme will be introduced this season for Members who participate in all activities of the Board, i.e. examinations and carnivals. It is hoped that this scheme will provide some recognition for those members who are really taking the burden of Board work seriously. Sponsorship and Board generated funds will have to be looked at seriously this coming season. The programme envisaged by the Executive will need funds to make them work fully and unless the Branch can help, the Board will need to gain its own sponsorship.

I would like to thank the Presidents and Committees of all Clubs for their co-operation during the year and especially to those Clubs who have hosted Board sponsored field days and meetings. The Board is indeed fortunate to be able to use your facilities and is very grateful. I would also thank the office staff at State Centre, headed by Joan Vaughan, Julie, Henry and State Administrator Ernie Davis; my requests for assistance and work to be done have been carried out quickly and I am very appreciative of your efforts.

To Bill Marshall, our retiring Branch President, I would like to sincerely thank you on behalf of all Board Members for all the help and co-operation you have given to the Board during your 5 years in office.

Finally, to my fellow Board Members and Board Executive, thank you for your help and co-operation during the past season, you have made my task pleasant and extremely satisfying.

The dedication to Lifesaving by Members, to the Branch and its Clubs can be demonstrated in the hours spent at meetings, sub-committees, seminars, instructional nights, field days, up-dates, demonstrations, examinations and carnivals in and out of season.

The year has had its problems and successes. The continual failure of the Clovelly Club to reach a satisfactory standard of patrols saw the need for a select committee to be formed by the Branch and recommendations and guidelines have been formulated for the coming season. The position of JRB Supervisor was not filled for the full season which left the Groups without a direct representative to the Branch and necessitated representatives being called on occasions to Board Executive meetings.

On the success side there was enthusiasm in the activities of the Board and a continued increase in membership. The Board seminar kindled ideas and comradeship so necessary for us to progress. Ron Day also successfully completed his first year as Carnival and Competition Supervisor. Jim Connolly must be thanked for filling-in so ably when Mick Berger was unable to continue mid-season as Cronulla-Sutherland District Supervisor due to ill health. Mick was a loss to the District and the Board Executive but fortunately he is now recovered.

The retiring Officers, Dave Popplewell the Randwick District Supervisor has won the respect of the District over the last 5 years. He has honestly handled the situation at Clovelly, always considering the best interests of the Club. Ian Badham has also indicated he will not be seeking the position of Helicopter Director and he must be thanked for his service to Lifesaving within the Branch. Ian's expertise, perserverance and involvement have seen the Sydney Branch Wales Helicopter Rescue Service pioneer and maintain the position as pacesetter for surf and other helicopter rescue services throughout Australia during the past 10 years.

I would like to congratulate all Members of the Board for sticking to the job and I am sure that with the influx of new Members and an active programme, the Sydney Branch Board of Control can face the future with confidence.
