Ladies and Gentlemen,

It gives me great pleasure to submit for your consideration and adoption, the 40th Annual Report of Sydney Branch, Surf Life Saving Association of Australia Inc., covering our activities for the 1988-1989 season.

Forty seasons have been completed, since the Branch was formed, on October 4, 1949, following the reorganisation of the then Head Centre, into National Council and State Centre.

Originally, the boundaries stretched from Barrenjoey in the north to Bald Hill on the south, encompassing thirty-two Clubs. With the establishment of Manly-Warringah Branch in 1960, this number was reduced to our present fifteen Clubs on the southern side of the Harbour Bridge.

Following the lively Bicentennial Year, season 1988-89 has been just as demanding on all of our resources, however our responsibilities as Lifesavers, to the community of Sydney has not diminished and, I have

pleasure in reporting that no lives have been lost on our beaches, whilst patrols have been on duty.

Sydney Branch patrols the coastline from Burning Palms, in the south to North Bondi. Over 2,500 Active Lifesavers, voluntarily maintained patrols every weekend and public holiday from late September to Anzac Day — the longest patrol season of any Branch in Australia. Every one of these Lifesavers has completed and passed a proficiency test, before being allowed into a rostered patrol. In these tests, our Lifesavers have to demonstrate their fitness and abilities with resuscitation and rescue techniques, using rescue boards and rescue tubes.

Examinations conducted resulted in a grand total of 1,111 Lifesaving Awards being gained by members of the fifteen Clubs. This figure is well below that of 1,404 for the previous season and is no doubt, a result of the atrocious weather conditions that prevailed for most of the season. Bronze Medallion Awards gained numbered 391, a decrease of some 24.2% on last year's 516 awards.

However, Surf Life Saving Certificates, primarily gained by members under 15 years of age, increased slightly to 257 awards over last year's figure of 241.

By comparison, figures from the previous season, showed increased Bronze Medallions (up 4.7%) and a large decrease in Surf Life Saving Certificates (down 46%). Although there has been a turnaround for SLS Certificates, there is still considerable cause for concern — Bronze Medallion Awardees form the nucleus of our voluntary patrols.

Our Clubs, especially some of our largest, will need to take stock of their situation, with some dropping their BM Awards gained by more than 100%. Bondi from 56 last season to 20, Bronte from 33 to 15, Cronulla 40 to 20 and North Bondi 66 to 27. However, on a bright side, some of our smaller Clubs, who were struggling with Bronze Membership last season, have shown very good increases, including Garie from 8 Bronze gained last season to 13 gained this season, Clovelly from 1 to 9 and Era 8 to 16.

Other Clubs have maintained Bronze Awards gained from last season to this, but have shown drops in awards normally gained by Active Lifesavers.

Advanced Resuscitation Certificates fell from 225 to 161 and First Aid Certificates from 41 to just 5 this season, but Inshore Rescue Boat Drivers' Certificates rose from 28 to 45 an increase of 60.7%. The figure for IRB Crewman's Certificates in the Awards' Table reflect the amalgamation of this award into the Bronze Medallion syllabus.

No clear conclusions can be formed as to why the figures for awards are down. Past, long-term statistics of the Association, indicate there are "waves" of rises and falls in awards, some, coinciding with changes in our instruction and examination syllabus and others, for no explanation at all.

One of the greatest contributing factor to this season's decline in basic Lifesaving Awards is, I believe, the unseasonable weather conditions experienced during the November to February period, when most new members are trained and examined. Notations recorded in many Clubs' Patrol Log Books showed that our beaches had dangerous surf conditions and were closed to swimmers on more occasions than they were open and safe. A table of statistical trends in the Branch, for the years 1949-50 to 1988-89 is reproduced later in this Report.

However, the Awards of Surf Life Saving Certificates and Bronze Medallions are those primarily gained by new Active Lifesavers. With a general loss of some 25% of Active Membership each year, (Australia-wide), when compared with the Membership Tables, are generally a good indication of the strength of our Clubs.

Total membership figures for our Clubs this season was 6135, a small decrease of 2.86%, from 6316 last season. Value of Club's rescue equipment rose some \$24,654 (4.17%) from the previous value of \$591,150.

Surf Rescues undertaken by Members of our Clubs this year totalled 1,200, a large decrease (37.59%) on last year's figure of 1,923, however first aid cases treated continued to increase by 14.29% from 3,036 last year to 3,470. IRB Rescues still accounted for nearly a third of all rescues performed (31.33%). Rescues this year by IRB were 376 compared to last year's 562 a drop of some 33.09%. Compared to other methods of performing rescues, those undertaken with Reel Line and Belt, still show a steady decline (8 last season or less than 1% of all rescues) These figures are a reflection of our new training methods, with more emphasis being placed on using rescue boards and rescue tubes. Rescue Boards accounting for 36.41% of the total rescues and Rescue Tubes, 9.41%.

Clubs in the Branch held eight open and the Era Craft carnival during the season, whilst the Wanda Club hosted the Branch Championships. As well as open carnivals, a number of special events were also conducted by the Branch, including the George's River Sailing Club Botany Bay Bash, Pier One (Surfboat marathons) and Yarra Bay Sailing Club Sydney Branch Stillwater Championships (Craft). A very successful winter board riding competition was inaugurated in the Branch and is continuing this winter with open championships being held in early September. Two rounds of IRB Competition were held at Bondi and the Branch IRB Championships at Maroubra.



The Branch Office continued to operate from premises provided by the Prince Henry Hospital at Little Bay. As well as office accommodation and meeting rooms, our small cottage incorporates the Branch Radio Room, "Sydney Surf". The hospital administration have also kindly allowed us to install radio aerials high on hospital buildings, thereby increasing our radio communication capabilities with our Clubs.

As mentioned in our last annual report, Joan Vaughan retired from the Branch in February. The Branch Christmas party was used as an informal opportunity by Clubs to express their appreciation to Joan for her service to the Branch. More formal presentations were made at the February Branch Council Meeting. Joan is presently on an extended overseas holiday with her husband John.

Congratulations are extended to John Vaughan, having been awarded the OAM in the Queen's Birthday Honours in June this year.

In February, interviews were held to find a replacement for Joan and, I am pleased to report a new office secretary, Pamela Harris, was engaged to work for the Branch. Pamela, not having a Surf Club background, has coped extremely well with our work and seems to have settled into the routine of working with the Honorary Officers of the Branch.

Equipment at the office, includes a facsimile machine and a computer, the latter, of great benefit to the Officers and Clubs now that it is being utilised more fully. When the computer is fully programmed, greater time savings will result in many of our administrative tasks including recording and processing of awards and carnival entries.

Our Board of Lifesaving Control have also worked extremely hard this season under the leadership of Trevor Elliott. Trevor was again elected Superintendent at the recent Board of Control Annual Meeting. This makes Trevor the longest serving Superintendent, now entering his tenth term.

Included in this year's activities for our Board, apart from conducting the annual proficiency tests of 2,500 Active Lifesavers, examinations on 30 occasions, for Bronze Medallions alone, other award examinations and the regular hours of instruction for Club members and officiating at carnivals, was the massive task of introducing the new air-bag resuscitator.

The air-bag replaced the oxyviva resuscitator this season and all Advanced Resuscitation Certificate holders had to be re-examined in the use of the new equipment. In addition, all Active Members had to be familiarised up to Bronze Medallion standard with the new equipment as well.

The Board also trialled a new organisational structure this season. It introduced a new position, that of Lifesaving Supervisor, in addition to the positions of Examination and Instruction and Carnival and Competition Supervisors. The Lifesaving Supervisor is responsible for the lifesaving activities of the Branch. The area of responsibility for this Supervisor embraces the District Supervisors, IRB, JRB/ORB, and Radio Supervisors as well as the Emergency Services Officer.

Meetings of the Board were also sectionalised. No longer is it necessary for Members to attend meeting in which they have very little, or even no interest. This is especially so for Members who only conduct examinations or who only attend carnivals.

The re-structure has worked reasonably well through this season's trial period and formal adoption of the structure into the Branch's Constitution will take place next season.

In the sphere of mobile services, the Cronulla Sutherland District's Offshore Rescue Boat had its experimental status lifted by National Council and is now fully operational. Named "The Captain Cook" the craft is a twin engined Cougar Cat and from its base at Cronulla is capable of reaching any beach in the Branch, in less than thirty minutes.

In its first season, fully operational, ORB2 was on duty for more than 640 hours of patrol, covering 3,000 kilometres. It performed 53 rescues and towed 24 other boats to safety, the value of which is estimated to be over \$1.5 million.

The craft was also of great benefit to the Royal National Park Clubs, during the bushfires earlier this year, when the National Park was closed to vehicular traffic. On one such occasion, ORB2 was able to transported equipment and personnel to Burning Palms Beach, so that fire-breaks could be cleared around their Clubhouse.

Jet Rescue Boat 3, from the Randwick District, continued effective patrols north of Botany Bay to Sydney Heads. The craft, run by the Randwick District on behalf of the Branch, is fully funded by the Randwick Municipality. Statistics for this season's operations show 13 rescues, over 300 operational hours covering nearly 2000 kilometres. Other boats towed to safety by JRB3 numbered 10.

Sydney Surf, the Branch Radio Room, continued to service our Club's emergency radio network. Manning of the room

proved not to be such of a problem as was expected. Operators from most of our Clubs volunteered to man the room, in addition, in some instances, to their other regular beach patrols. The following table indicates the contribution by Clubs' members to the operation of Sydney Surf:—

As mentioned previously, the UHF Radio network, in the Branch, has been further upgraded with the installation of new aerials on hospital buildings. All of our Clubs are now capable of talking direct to Sydney Surf from their beach patrol areas with portable UHF radios.

The repeater network, installed by State Centre, has maintained its worth for the Clubs of the Royal National Park. This season, they have again used it, during patrol hours, to call for help from other emergency services like the Westpac Helicopter.

Outside of patrol hours, the Clubs are able to call for assistance through the Wollongong Ambulance base, who monitor our Channel 2 rescue frequency. However, the repeater system will not reach its maximum potential until the link between the Saddleback and Bronte repeaters is again fully operational. When this happens, the Clubs of the National Park will be able to fully participate in the Branch's 24 hour emergency callout operations.

During the season, a number of special incentive awards for Clubs were conducted, including the Telecom IRB and Rescue Board, the Mayne Nickless IRB and the Aquatic Club Don Lucas Memorial Gear Trophy.

Telecom provided the State Centre with two fully equipped IRB's and a number of rescue boards, the IRB's to be used in both Sydney and Manly Warringah Branches. Sydney allocated the IRB and Board to an incentive competition. Clubs, to be eligible for the award had to complete the season with no patrol defaults, provide 30 hours duty at Sydney Surf and compete in the Branch Patrol Championships. At the conclusion of the season, Wanda Club won the IRB, South Maroubra the Motor and Fuel tank and Cronulla, the Rescue Board.

The Mayne Nickless IRB is yet to be won; the incentive scheme continues until the end of August. The winner will be decided on the result of which Club gains the most IRB Drivers, Instructors or Examiners Certificates as a proportion of their Active Membership.

Knowing, at the beginning of the season, these two IRB's were to be provided as sponsorship, enabled the Branch to introduce these incentive schemes. I would thank Telecom for their three year sponsorship of the State Centre and also Mayne Nickless for their continuing sponsorship.

In memory of the late Don Lucas, the Aquatic Club of Potts Point make available the Aquatic Club Don Lucas Memorial Gear Inspection Trophy. Held in conjunction with gear inspection at the start of the season, South Maroubra were declared the winners. The Panel also commended both Bronte and Elouera for the remarkable improvements made by these two Clubs.

The Zodiac IRB Trophy is based on the number of IRB awards gained during the season, by Clubs as a percentage of their Active membership. This year the Trophy was won by Garie, gaining 10.53%, followed by Burning Palms 6.67% and Cronulla 4.14%.

The Harry Brown IRB Trophy recognises the Club with outstanding performances with their IRB at Gear Inspection, with Awards gained and with participation in the Branch IRB Championships. This season, the Award is made to North Cronulla.

The Peter Doolan Shield, although not an incentive trophy, is for a special competition conducted amongst our board riding members and those of Manly Warringah and other Branches. A special tag-team event is held to select the winner. The event, held this year at Wanda resulted in a win by the Manly Warringah Branch.

During September, last year, the Board held conferences for Club Captains, Chief Instructors and Gear Stewards. All were well attended and the benefits gained by the Branch from those Clubs attending made them all worthwhile.

The Club Captains' conference was held at Prince Henry's Function Room. As a result of this conference, a far reaching policy regarding patrol obligations, a method of dealing with defaults and a rationalisation of patrol hours and manpower was achieved and implemented for the season. It took account of daylight saving periods and beach usage by the public to attain maximum efficiency with out patrols.

Although gaining State Centre endorsement, it was disappointing, that, in the latter half of the season, the National Superintendent asked for the patrol hours and manpower levels to be change back, to those of the previous season.

In the second half of the season, a generous donation by SmithKline Biologicals enabled all Active Members to be immunised against Hepatitis B. Our Lifesavers are at risk of contracting this disease through needles found on our beaches and through firstaid treatment of infected patients. A large amount of organisation for the programme was undertaken by all Clubs and I would thank those Doctors and Nurses who voluntarily administered the injections.

Our thanks also, to SmithKline Biologicals, for providing the serum and syringes at one-fifth their normal cost and the fact they will continue it next season for our new members.

In January, National Council held the Australian International Youth Life Saving Training Camp. Designed to provide an opportunity for participants to exchange

knowledge and experience, it also enabled them to receive invaluable training in life saving management and skills.

Participants — all under the age of 25 years — were selected from all Clubs in Australia to attend. Those selected from our Clubs were James Corcoran (Coogee), Timothy Thompson (South Maroubra), Matthew Scott and Troy Latter (Wanda), Paul Scullion and John Restuccia (Maroubra).

John Restuccia, selected from young Life Savers as the New South Wales recipient of the Sir Adrian Curlewis Scholarship, is to be congratulated on receiving this award, which enabled him to attending the Camp.

Our congratulations to Dr. Ian Mackie, on receiving an AM award in the Queen's Birthday Honours in June and to Nick Dixon on his elevation to Life Membership of the Association, in April this year. Dr. Mackie has long been involved with research and training of our examiners in resuscitation techniques and, is a worldwide authority on the subject.

Nick Dixon, is a long standing member of our Board of Control, having been the convenor of the Gear Inspection Panel for a number of years. He is also a Life Member of his Club, the Branch and State Centre. Nick has provided distinguished service as an officer with his Club, Cronulla, the Branch and State Centre and is continuing this service, as President of the Far South Coast Branch.


BRANCH SPONSORS

As a result of successful negotiations by the National Council to the Federal Government, a Direct Assistance Grant was successfully negotiated for our Garie Club. The Club received funds which would otherwise be too much for their own resources, to purchase and install a much needed new generator for light and battery charging.

Mayne Nickless

This season, Mayne Nickless again provided five IRB's and motors for competition at selected open carnivals. At the end of the series of events, they donated the craft to five Branches. Sydney Branch received one of these craft,

valued at over \$8,000. The IRB is being used as a prize in an incentive programme to encourage our Clubs to gain additional IRB Drivers, Instructors and Examiners Certificates. The scheme will conclude in August this year.

Mayne Nickless also sponsor the popular Surfboat elimination competition, conducted in all Branches, with the final being held at the Coogee Carnival. Three rounds of the competition were held in the Branch, at Era, Cronulla and North Bondi Carnivals.

Telecom

This season, Telecom made a donation to State Centre to purchase two IRB's and twenty Rescue Boards. Sydney Branch was allocated an IRB and Rescue Board, which were used as prizes in an incentive programme.

REMEMBRANCE

James Wishart Dempster, Branch Life Member, passed away on August 15, 1988, aged 86 years.

Jim joined Dee Why SLSC in 1914, gained the Bronze Medallion in March, 1918 and Instructor's Certificate in April, 1920. His first office in the Club was that of Vice Captain in 1919-20, followed up with three seasons as Club Captain, 1921-24, Secretary 1925-27, 1930-33, interspersed with Boat Captain, 1928-29.

He was elected a Life Member of Dee Why SLSC in 1929.

Prior to the establishment of National Council, NSW State Centre and Sydney Branch in 1949, the Association was administered by a Head Centre, based in Sydney. It was at this forum that Jim served as a Vice President (1941-48) and as a delegate for Queensland State Centre, representing that State for twelve years (1936-48).

At Sydney Branch, he was Vice President (1949-50) and Delegate to NSW State Centre (1953-55).

Jim Dempster was awarded Life Membership of Sydney Branch in 1959 and following the formation of the Manly Warringah Branch, was also made a Life Member of that Branch.

Jim was Purchasing Officer (1955-59) of NSW State Centre and was created a Life Member in 1963.

His connection with the Queensland State Centre did not conclude with the demise of Head Centre for he continued to represent that State Body as a Resident Delegate to National Council for another eight years (1951-59) — all told he has represented them for twenty years.

As a tribute to his long and dedicated service, Jim Dempster was elevated to Life Membership of the Association in 1966 — a fitting reward to a grand old gentleman and Lifesaver.

Sydney Branch conveys deep condolences to his family and friends.

Anthony John Purcell, Branch Life Member, died on August 23, 1988, aged 72 years.

Tony joined Cronulla SLSC as a junior in 1932 and gained the Bronze Medallion in November, 1933. He served the Club in the various offices of Registrar, Publicity Officer, Assistant Secretary, Boat Captain (1938-41), Club Captain (1946) and President (1949-52).

Tony's role as a competitor concentrated on surf boating in which his major success was to sweep the junior crew to win the 1939 Australian Championship.

His sweeping prowess also came to the fore when he and his 'scratch' boat crew figured in the mid-week rescue of a swimmer off Cronulla Beach on March 17, 1937. For his efforts he, with others, received the Certificate of Merit Award of the Association.

In 1940, Tony enlisted in the AIF and saw service in the Middle East with the Anti-Tank Regiment, before transferring to the newly formed 1st Paratroop Battalion. He was Sergeant Major in charge of the guard at the Japanese surrender in Singapore in 1945.

Tony was accepted onto the Board of Examiners in 1939 and officiated at carnivals in the area of his first love — surfboats — and it was in this sphere as a Referee, Starter and Judge, that he was best known to competitors and officials.

Among his proudest appointments were Boat Referee of the 1954 Royal Surf Carnival and the 1957 Jubilee Australian Surf Championships, both held on Bondi Beach.

Tony was elevated to Life Membership of Cronulla SLSC in 1949 and Sydney Branch in 1960.

In 1961 he moved residence to Tea Gardens, north of Newcastle, where, apart from being mine host at the local inn, he was involved with the formation of Tea Gardens-Hawkes Nest SLSC and became its President, Patron and first elected Life Member.

Following the passing of Don Lucas OBE in 1983, Tony was elected to the esteemed office of Patron, Cronulla SLSC, the position he retained till the time of his death.

Tony Purcell's funeral service was held at Beresfield Crematorium on August 25, 1988 and his ashes scattered off Cronulla Beach on Sunday, October 23, 1988.

Sydney Branch expresses deepest sympathy to his wife Joan and the family.

Ronald Victor Buist, Branch Life Member, passed away on January 17, 1989, aged 57 years.

Ron joined Tamarama SLSC in November 1949 and gained his Bronze Medallion in January, 1950.

It was obvious from the start of his career that Ron had a flair for administration, for very soon after joining, he held a seat on the committee and took up office with the Club. He was Publicity Officer, Assistant Secretary and served a six year term as Secretary before shouldering the mantle of Club President from 1961 to 1968. He was elected a Life Member of Tamarama SLSC in 1960.

Following his retirement from Presidency, he centred an interest in the affairs of Sydney Branch and the other levels of the Association, becoming Branch Deputy President (1968-73), President (1973-77) and Delegate to NSW State Centre (1971-78) — serving thirteen years with the Branch as an elected officer, Ron was granted Life Membership in 1980.

While still maintaining a keen interest in Sydney Branch, he proceeded to hold executive office at NSW State Centre, as State President, for six years (1978-84). Ron was elevated to Life Membership of NSW State Centre in 1982.

At National Level, he was Delegate for NSW State Centre (1975-84) and a regular member of the National Meritorious Awards and Constitution Sub-Committees.

Ron's contribution to Surf Life Saving was recognised in other areas when he received a Citizen Commendation Award from Waverley Municipal Council in 1976 and the Citation of Merit from World Life Saving in 1983.

National Council bestowed on him its highest honour in 1984 — Life Membership of the Association — highlighting a distinguished service of commitment and dedication.

During a remarkable thirty-eight year membership Ron's service as an officer spanned an unbroken period of thirty-three years, of which twenty-eight years were in an 'executive' role.

Ronald Buist's ashes were scattered off Tamarama Beach on Sunday, February 12, 1989 at a ceremony attended by Club members, relatives and friends.


North Bondi conducted the Fosters Iron Man, and Cronulla, the Bate Bay Surfboat Marathon.

Branch Patrol Championships

Were conducted at Wanda on January 29. It was disappointing not have had all fifteen Clubs competing in this special competition, designed to demonstrate general Lifesaving skills amongst our patrol members. Wanda won the Championships on 665 points, with Tamarama (552.5) and Cronulla (480.25) taking second and third place. Elouera, Maroubra, South Maroubra and North Cronulla, were the other Clubs in the Branch who competed at the Championships.

The Championship is run on a pointscore basis and is structured so that the ability of a patrol to deal with a rescue situation is taken into account. No distinct advantage is gained by having a large number of members in the patrol, nor the fact that a patrol may contain a large number of specialist competitors. Our smaller Clubs are not disadvantaged and are able to compete on an equal basis with the larger Clubs of the Branch.

Inflatable Rescue Boat Championships

Two rounds of IRB competition were held this year, to select teams for entry into the State IRB Championships. One of these rounds was the Branch IRB Championships, which were again sponsored jointly by Buttercup-Vogels Breads and Kenwood Appliances. 

Mayne Nickless Surfboat Competition.

BOARD OF CONTROL REPORT

Following what can only be described as a hectic season during the Australian Bicentennial Year, it was considered that activities across the broad spectrum overseen by the Board, would slow dramatically. Nothing could have been further from the truth. Board Officers and our various Sub-committees, have been extremely active in their duties.

One of the most important tasks undertaken by the Board during the season was to trial a proposed restructure of its activities into three specific areas. These were Lifesaving, Examination and Instruction and Competition. Proposals were submitted in an endeavour to enhance the knowledge and skills of those members who have a particular interest in one of the three strands available to them. Notwithstanding, full Board members retained their right to attend all meetings, training sessions and seminars of the three strands or to specialise in a combination according to their choice.

Three Supervisors were appointed to head these sections of life saving activities and were Bruce Breadner, Life Saving Supervisor, Bob Brandson, Examination and Instruction Supervisor, whilst Ken Metcalf assumed the role of Carnival and Competition Supervisor. These three officers gave an immense amount of time to their tasks and reported directly to the Superintendent and the Board Executive. They carried out their duties in a competent and efficient manner and thereby ensured that the proposed structure was given a fair and meaningful trial. At the time of compiling this report negotiations were underway with the Sydney Branch Executive in relation to attendance criteria and voting rights at the Branch Management and Branch Council Meeting for these officers.

During the season the Board conducted 16 meetings for the membership and they were divided into categories consisting of two full Board Executives, two full Board, six Lifesaving, three Examination and Instruction and three Carnival and Competition meetings. Whilst attendance varied on each night, the resulting input and output was beneficial to both the Board membership as a whole and to the Clubs which the Board services within the Branch and at other levels of the Association.

The season again saw a highly successful Club Captains Meeting being held prior to the commencement of Beach Patrols. This conference was conducted in the Functions Room of the Prince Henry Hospital on Saturday, 30th July, 1988 and was attended by all Clubs within the Branch with the exception of the Cronulla S.L.S.C. The meeting saw the Club Captains and Board representatives re-shape the Branch's policy on patrol obligations and was universally adopted throughout the Branch.

As mentioned the Branch implemented a new patrol obligation a few clubs were found in breach of that agreement, whilst difficult decisions had to be made the offending clubs complied with the agreed penalties imposed. Whilst feelings regarding the patrol obligations have been voiced throughout the Branch, it is certainly true to state that the standards of our patrols have risen greatly because of the introduction of the system.

Our gear inspection panel again continued with its important task of checking all the clubs equipment prior to the commencement of beach patrols. The South Maroubra Club were the outright recipients of the

South Maroubra Club were the outright recipients of the D.C. Lucas Memorial Gear Inspection Trophy with no faults being found with their equipment. The work of this committee is vital and ensures that when clubs begin patrolling their respective beaches their gear and equipment is in first class condition and ready for any emergency that may arise.

A Chief Instructors night was held for the Randwick and Waverley Districts on September 19th, 1988 and another for the Cronulla-Sutherland District on September 21st. This was the first time that a meeting of this type was divided on a district basis and enabled Board Officers to give more personal attention to Club Chief Instructors on Board requirements in training and examinations.

Training for all Board members on the air bag resuscitator and an ARC update was conducted on September 28th and was both well attended and highly informative. The new air bag resuscitator being the most important agenda item of the evening.

Proficiency testing was carried out on seven occasions at 23 locations by the Board to ensure that all life savers were able to carry out the requirements of rescue work within the Branch. A small committee was formed by the Board to review the proficiency testing system within the Branch and their recommendations have been adopted. Next season will see proficiency testing being done on a patrol basis in lieu of the current set day method. The processing of the administrative side has also been streamlined and will ensure that the testing system is more accurate and efficient.

The Board oversaw the conduct of the Branch Patrol Championships which were conducted on January 29th, 1989. The format conducted by the Branch stipulates that only a recognised patrol can compete and regrettably this competition on patrol skills and knowledge does not align with the Australian Championships. However, our competition is fiercely contested by those clubs who regularly participate.

At the N.S.W State Championships it was pleasing to note that the Tamarama Club attained second place and the silver medal and congratulations are extended to all members of that patrol.

On the Examination and Instruction side of the Board's activities. Board members examined a large number of squads on 15 occasions at some thirty different locations. However, our Examination and Instruction Supervisor, Bob Bransdon, has pointed out the dramatic drop in Awards, particularly Bronze Medallions. All clubs have

been advised of this through the regular provision of statistics supplied by Bob at Council meetings and it is a matter of grave concern to both the Board and Branch Executive alike.

Carnival and Competition Supervisor, Ken Metcalf presided over 3 carnival and competition meetings as well as overseeing special events including the Rossfield Trophy, the Stillwater Championships and the Inter-District and Inter-Club Carnivals.

The expertise of our members in competition has been recognised by the Association and it is pleasing to note the number of our members appointed to championship carnivals. At the Metropolitan Championships we provided 4 referees and 26 officials, while 3 sectional controllers and 20 officials participated at the NSW Inter-Branch Championships.

At the NSW State Championships the Board provided the carnival referee and 2 sectional referees as well as 51 officials. The Australian Championships again saw the Board well represented by providing the carnival referee, two sectional referees and no less than 37 officials for the many facets of operations that go into running a national championship which has more competitors than the Commonwealth Games.

A special tribute is also made to Kim Wilson who has taken the running of the winter and summer board riding series under his personal supervision. His efforts and those of his colleagues have seen a major increase in the number of board riding competitors and the standard of board riding is a sight to behold.

The Board has been involved with and participated in a number of projects during the year and these have included the investigation into coastal development policy, Hepatitis B vaccinations and has been signalled of the ramifications that can occur when disabled persons make application to become fully qualified life savers. We now face the reality of having to come to terms with anti-discrimination legislation and legal challenges to decisions made at competition events.

These new challenges that we now face must be met with clear policies laid down and the knowledge that decisions taken and implemented have been correct and in accordance with the rules and requirements of our Association.

SUPERINTENDENT'S REPORT

This Fortieth year of Life Saving for Sydney Branch has witnessed another year of dedication by the Clubs and the Members of the Board.

The major internal changes to the Board of Control which involved the splitting of the roles of the Board into three streams, namely Life Saving, Examination/Instruction and Competition, I believe, have been successful and allowed the concentration of efforts of the officers and the panel members on their respective duties. The regime of meetings under each particular chairman has encouraged valuable informed discussion and lead to a better performance by the Board.

The year of operation of this system under an arrangement where the Constitution was suspended has proved beneficial and a final recommendation is now formulated for review by the Branch Constitution Committee.

This proposal will include a revised list of duties for the officers and a more structured recognition by the Board in the areas of Special Events, Endurance Events, Displays, Board Riding and IRB Competition. The Emergency Services Officers' Duties will include acting as Deputy to the Life Saving Supervisor. It will be necessary for the Branch to recognise the three Supervisors at Executive and Branch level as representing their sections and being directly answerable to the Branch in their areas of expertise. In recognition of this added responsibility it has been decided that the previously vital role of Deputy Superintendent has been overtaken by these Officers and they will now act as Deputies to the Superintendent in their own right.

During the Winter months meetings were held to reformat the Branch Information Directory and to revise the Branch Patrol Hours of Duty to represent the needs of the public and the obligation we owe as Surf Life Savers. Out of these meetings, and with the positive contributions of the Club Captains, the Branch was able to put in place an agreement which acknowledged the duty to protect the public who swim at surfing beaches and the obligation and awareness of the responsibility to maintain efficient patrols.

This document was designed as a tool for the betterment of life saving and gave guidance for local conditions outside those areas covered in the Association Manuals. A major segment of this agreement was the requirement that clubs advise the Branch of shortcomings in any particular patrol.

The document also set up a milestone system of patrol infringement reporting that could lead to the recording of a major infringement and the possible suspension of a club. The mechanism was also put in place for the prompt handling of appeals through a Tribunal, circumventing the lengthy process involved in Branch Judiciary Committees.

It was disappointing that after the necessary approvals had been gained from State Centre, and all aspects implemented, questioning of the document appeared in National Council Minutes. The subsequent querying of the Patrol Hours from the National level, in February, saw it necessary for the Branch to capitulate and agree to extend patrols by one hour outside daylight saving hours. This countered the much professed policy of flexibility and patrolling to the needs of the public and we saw patrols at the end of April finishing at the same time, after discounting for daylight saving, as was required in the peak of the season. Practice proved that the Branch Hours were more than adequate.

I have regularly attended the Life Saving meetings under the Chairmanship of Bruce Breadner. These monthly meetings have allowed positive review of lifesaving in the

Branch and given Bruce the opportunity to tie together the "Life Saving" duties of the Board. This group has had a successful season and they are to be thanked for their efforts.

In particular the District Supervisors, Steve Strange, Peter Calder, Mark McFarlane, George Shales and their Assistants have borne the brunt of the workload and have been most active ensuring patrol standards were upheld and in conducting preliminary examinations. Their efforts were commented upon by the Examination Supervisor as contributing to the high standard of candidates presented for examination.

An important development pioneered by Graham Smith, our Emergency Services Co-ordinator, was the appointment of District Rescue Co-ordinators. These people, who in some cases were the District Supervisors, were available to oversee the involvement of Branch facilities and were also available to expedite communications via the UHF portable radios made available through a donation by the Aquatic Club and the \$ for \$ Grant.

The Radio Network and the operation of the Branch Radio Room have had major revitalisation this season. Ian White as the Branch Radio Officer has overseen this with a keen band of operators. The Branch was able to recognise this duty and present these people with Branch Shirts in recognition of their services.

Ron Camilleri continued his work with the Cronulla-Sutherland Offshore Rescue Boat and the Randwick Jet Rescue Boat and both these craft saw a minimum downtime during the season and the members of the groups spread the horizons of rescue work. The lifting of the experimental status from the Offshore Rescue Boat and the recent qualification of John Cox as an ORB Examiner will now see the examination of suitably qualified members of this group for their ORB awards.

The Inflatable Rescue Boat Panel have again performed enthusiastically under the leadership of Bill Singleton. The numbers of drivers examined from Clubs has shown a 25% increase although more candidates should be expected if clubs are to fully roster IRB's to patrols.

The efficiency of these craft has again been limited by the non-availability of reliable waterproof radios. The Branch has now taken the initiative to find the best of the components available in an attempt to produce a suitable unit during the winter months.

The IRB section continued to strongly advocate the need for higher training of crew persons after obtaining the Bronze Medallion, and the re-introduction of a Crewmans Certificate.

Mention should also be made that the Mayne Nickless IRB which is operated by this group has given invaluable service as a training boat and also in carnival work.

The most conspicuous area of the Board of Control activities is that of Examinations and Bob Brandson and all the examiners have performed the duties expected of them. The recorded downturn in awards is of obvious concern particularly in the overall Bronze Medallion figures. A major factor was that the North Bondi, Bondi, Bronte and Cronulla Clubs only achieved half or less Bronze's than in the previous year. The smaller Clubs of Clovelly, Era and Garie showed good growth.

In the Carnival and Competition area a very full programme of events has been run under the supervision of Ken Metcalf. Ken was backed up by an expert panel of referees and officials who have drawn favourable comments from competitors from both within and outside the Branch. I can only concur with their opinion of a job well done.

At carnivals we would not be able to operate without the backup that is provided by Arthur White as Branch Gear Steward and his care of the carnival gear. Ann Ainsworth was again responsible for the Board gear and stationery and also acted as Minute Secretary for Ken as well as organising the fund raising that saw board members equipped with the wet weather gear so necessary this season.

Ken English, the Deputy Superintendent, deserves thanks for his efforts during the season. Ken has been active in all areas of the Board's endeavours and again successfully convened the Gear Inspection Panel.

I would also record thanks to the Branch Office for its support during the season. Firstly to Joan Vaughan, now in retirement, and to Pamela Harris for their assistance during the year.

TREASURER'S REPORT


The Budget, adopted by the Branch Council in March, 1988, has resulted in an operating profit of \$30,582 after allowing \$5,397 for depreciation. No provision is made for annual holidays as this was expended during the financial year. A comparison of the last six years results shows we still have a way to go to make up the loss.

Income

Income rose from \$163,304 in 1987/88 to \$189,569 in 1988/89 or 16.08%. The biggest increase was in interest and is the result of current high interest rates. While sponsorship and donations accounted for 47.7% of income (a drop of 0.49% from 1987/88) interest accounted for 6.76% an increase of 4.76%. Despite restrictions on Government spending, the Government Grant was the same as the previous year. To our sponsors and all who supported the Branch (detailed elsewhere) my thanks.

Income 1988-1989





Unfortunately, this cannot be until financial support is received from the National Park and Wildlife Service. Must a fatality occur before something is done?

The District Committee was once again extremely active and dealt with a number of issues concerning the three Clubs. Our thanks go to Bob Davison as Chairman, who represents us at the Branch Management Committee and reports back to our monthly meetings in a true and accurate way.

Our lifesaving activities were under the supervision of District Supervisor, Steve Strange who in his first year has been worked hard especially with membership problems at Garie and the suspension of one Club for patrol defaults. We thank Steve for his tireless efforts, especially his support in arranging examinations for Garie to bolster their membership strengths.

The District Clubs continued to participate at all Carnivals as well as State and Australian Championships. The District again gaining fourth place in the Inter-District Championships and third in the Handicap Pointscore. All Clubs compete at the Rossfield Trophy with Burning Palms leaving the event \$2,000 richer. Our thanks are extended to Bernie Webb and the Directors of Rossfield Corporation.

CONCLUSION

There were none of the traumas of relinquishing control of the helicopter rescue service, moving the Branch office, nor the hectic rounds of Bicentennial events, as happened the previous season.

Instead, the season under review has been one of quiet progress for the Branch.

We have gotten on with the task of running the Branch in an efficient manner and, thanks to our move to Prince Henry Hospital, as some substantial cost savings. The transition period in February this year, when Joan Vaughan retired after many years with the Branch, was accomplished quite smoothly. Pamela Harris has coped well and is to be congratulated on "settling in" so quickly.

The change in the Association's resuscitation equipment, from the Oxyviva to the Airbag system, was completed with a minimum of fuss, including the retraining of members. As well, the Clubs' IRB's participated in a number of Bicentennial Year closing ceremonies, including the "Sound Cloud", Japan's contribution to our celebrations and the finale of the year, at Drling Harbour.

A major policy document for the Branch, the Patrol Obligations Contract, brought forward from the Club Captains' meeting in September 1988 saw our patrol resources used more efficiently. Although there was some criticism from sections of the Association, I believe they have now grasped the full and benefits of the policy.

Already, two meetings of Club Captains have been held and, with some minor changes, dealing with staying on duty after patrols cease, if beach usage by the public

warrants, the policy will again be implemented.

One of the results of the Board's restructure was the elimination of the role and position of Deputy Superintendent, the role now undertaken by the Lifesaving Supervisor. Ken English, our last Deputy Superintendent, had held the position for four years and, prior to this, was the Carnival and Competition Supervisor. Ken has worked tirelessly as Deputy to Trevor Elliott and, during the past year, as well as graduating from university, took on the added burden of administering the Board, in the absence of an elected Board Secretary. It is fortunate for the Branch, however, that Ken stood and was elected Secretary of the Board for next season.

Another Board Officer who has retired this year is Graham Smith. Graham had been the Emergency Services Officer of the Branch for three years. It was Graham, who co-ordinated and liaised with the MSB and Bicentennial Authority, for our participation in the unforgettable First Fleet Re-Inactment and other Bicentenary activities. Graham was also responsible for much of our present emergency services callout system and improved radio communications network, through his close contact with the State Radio Adviser.

One of the biggest concerns to our Lifesavers during the past and, in future seasons, is the question of water pollution at our beaches. Although the State Government is addressing the problem, it will, no doubt, be some time before the beaches are restored to anything near their former cleanliness.

A pilot study has been conducted by the State Health Commission, this season, to ascertain whether any health problems of our Lifesavers are caused as a direct result of beach water pollution. A major survey, by the Commission, will be carried out this coming summer and will involve questioning the general public and our Lifesavers.

The NSW Government through the Department of Sport, Recreation and Racing in conjunction with the Coastal Studies Unit of the University of Sydney and our State Centre, has also commenced a survey of all beaches in the State. The survey aims to grade the physical characteristics and hazards of beaches, as well as compiling a database on all aspects of the type and circumstances of rescues undertaken. I would urge all Clubs to conscientiously support both these important surveys.

As mentioned at the beginning of this Report, the average annual loss of Active Members each season is 25%. With some of our Clubs only gaining half the number of awards gained the previous season, they will need to make an extra effort to recruit and train new members. Nevertheless, to all of our fifteen Clubs, I would thank you for your Lifesaving endeavours and co-operation during the year. To those Clubs who have hosted Branch Meetings and lent your support to Branch events, thank you.

To our sponsors and donors, without whose tangible contributions our Lifesaving endeavours would suffer, I thank you sincerely and, no doubt these thanks are shared by the whole community who benefits from the voluntary efforts provided by our Lifesavers.

Finally, I would like to thank our President, Geoff Forshaw, for once again leading the Branch with his enthusiasm and dedication. To my fellow Executive Officers, I sincerely thank you for your efforts and support. To my Assistant Secretary, John Wardall, who was elected in January, thanks for stepping-in and easing some of the burden.

As this 1988-1989 season, the Branch's 40th year of operation, draws to a close, I look forward to the challenges of the 1990's with the knowledge that Lifesaving in Sydney Branch will overcome any they may bring.
