

Ladies and Gentleman

The presentation of this Report brings to a close yet another very successful season of the Sydney Branch Board of Control and it is with much pleasure that I present to you its 43rd Annual Report for the 1991/92 season.

The season under review will detail the activities of Life Saving, Examination, Instruction, Carnivals and Competitions conducted by the Board in fulfilling its obligations to the Sydney Branch and its Clubs.

As is usual with such a vast organisation such as ours, there are many people who contribute to the activities of the Board. The front line being the 88 Active Examination Members and the 76 Competition Officials who take time out each week-end to participate in the examination of club members and the conducting of carnivals within the Branch.

The season started off with the foundation being laid early with the Club Captains Conference held in July at the Prince Henry Hospital Function Centre. All 15 Clubs were represented in the day's activities. The Meeting concluded with a number of goals for clubs to aim for and policy's set for the season.

Of the goals the following were noted as high priority to Clubs.

- * The increase of IRB Awards
 - * Raising the standard of Patrol Captains
 - * The implementation of patrol uniforms within clubs.

In the pursuit of these goals the Board conducted numerous activities including:

Formation of District IRB Co-ordinators M.S.B. Licence Days.

Several Patrol Captains Seminars were held throughout the Districts with a total of 66 Patrol Captains lectured on patrol obligations, uniforms, public liability and the running of a patrol uniform competition, as an incentive, which involved a total of 5 inspections of each club.

The Board constantly reviewed the progress via additional meetings and an extensive mid-season survey. I feel the Board has been mildly successful in implementing these goals however they will need to be carried over into the forthcoming season for full advantage.

The first role, and the very essence of our organisation, is Life Saving and I would like to record the efforts of our Life Saving Officers under the leadership of George Shales, Life Saving Director. The Life Saving Board met on 12 occasions and has been instrumental in maintaining a high standard within the clubs. George is not seeking re-election next season and I would like to sincerely thank him for his contribution to the Board and the guidance he has given me over many years. I am sure he will not be far away in future seasons.

The District Supervisors, Peter Sullivan, Linda Mulhall, Glen Clarke, Kim Wilson and their Assistants are the officers most directly responsible for the day to day activities of the Board on a District basis. Conducting patrol inspections, preliminary examinations and ensuring that Surf Life Saving standards are maintained, enhanced and strengthened in their respective areas.

The commitment from the Emergency Services Co-Ordinator, Brad Taylor, has seen this area continue from strength to strength. Operating the Branch 24 hour call-out system, with the assistance of the Branch Duty Officers, Brad has ensured that Surf Life Saving has become the number one authority in surf rescue with statutory authorities.

The Branch Radio Room, under the control of Peter Fuller, was manned throughout the season as we have come to expect and has kept the umbrella of communications in tact. Stage three of the Radio Room has almost been completed to enable a broader range of communication through the Branch for next season. Peter has given the "assistance required" signal, mostly in vain, during the season in the hope of gaining new operators and clubs will need to look at their commitment to the Radio Room in the coming seasons.

Our prime method of rescue, the Inflatable Rescue Boat section, has been maintained by Bernie Kelly during the season. Bernie undertook several projects during the season including the reintroduction of Twilight IRB Carnivals and the co-ordination of IRB District Officers, which proved to be very successful.

The ORB has been well looked after by the ORB Supervisor, John Cox, who has shared his wealth of experience as a Senior Constable with the Sydney Water Police. The JRB3 group was not in operation during the season but has now taken delivery of a new 19ft craft and shall commence training during the off season setting the stage for an unprecedented coverage of Sydney's beaches by both groups next season.

Ursula Say filled the role of Examination Supervisor starting the season off with the Chief Instructors Meeting, followed by an Examiner's Day at South Maroubra which trialed a work station "hands on" format with a number of Board speakers. Imput by the examiners made the day quite profitable. The Board was also responsible for the examination of 1167 awards and over candidates for their proficiency test.

Looking after the interests of our Competition Officials Peter Steenson was responsible for the running of our 9 Open Surf Carnivals, 5 Boat and Ski Marathons, 5 Board Riding Events and several championship events. All up, a total of approximately 1500 competitors passing through the Branch Office computer. The season also saw a total of 87 officials completing their Officials' Accreditation course. One of the largest numbers in Australia. Luckily Peter does not face the daunting task of running Sydney's carnivals alone, he is backed up by such people as the Branch Gear Steward, Arthur White, who fronts up each week-end to personally take care of the carnival gear.

Kim Wilson, the Board Riding Referee, as well as all Carnival Referees and Sectional Referees put so much time into their respective areas.

I must also make mention of Denis Dick our Board Gear Steward who is not seeking re-election next season. Denis and Carmel are moving to Port Macquarie and we thank them for their contribution to the Board over the years and note that they will be sorely missed.

A number of Members served as Honorary Officers of the Association including: Bill Marshall, Deputy President of Surf Life Saving NSW, - John Fraser, Treasurer, Surf Life Saving NSW and the many Board Officers who were appointed to Championships Carnivals and supported the Association by travelling at their own expense.

I also wish to make mention of Mr. M. Wallace, Director of Prince Henry Hospital for his continuing support in the use of the Hospital Function Centre for our Board AGM and Captains Conference.

A New Members Indoctrination Evening was held at the Branch during the season by New Members Co-Ordinator, Bob Bransdon, with a good attendance. I would like to take this opportunity to welcome all new members to the Board.

As Board Members we are Life Savers from clubs privileged to gather together with likemined people to pool ideas and experience for mutual benefit, satisfaction and companionship.

I have enjoyed the workload of the past season in my first year as Superintendent but, more importantly, I extend my thanks and gratitude to all the Officers and Members of the Board in helping to make Sydney Branch the best branch in Australia, if not the world.





After tough negotiation at the Club Captains Conference, the finishing time for patrols was set at 4:00 p.m. I feel that the clubs have let the Board down badly as patrols were leaving the beach at exactly 4:00 p.m., regardless whether the public was still in the water or not. A timetable should not apply when public safety could be at risk and I therefore feel obligated to suggest patrol hours be set back to a 5:00 p.m. finish, afterall, the dangers of the surf do not go away just because it is 4:00 p.m., commonsense should prevail.

Over many past seasons, it has been noticed that the most important people in life saving, the patrol captains, are suffering from the "I don't know" syndrome. So it was decided at the Club Captains Conference to hold three Seminars for the Patrol Captains. These Seminars were found to be of great interest to the Patrol Captains who attended the Patrol Captains Conference as the topics were aimed solely at the Patrol Captains.

The Patrol Championships which were held at Wanda Beach turned out to be quite a dangerous exercise, due to the treacherous conditions of the surf. After the first club attempted the run swim run section of the competition it was wisely decided that it was too dangerous to continue and the run swim run section of the competition was abandoned. The rest of the competition ran smoothly and the best patrols in Sydney Branch are first Tamarama, second Wanda and North Cronulla third. It was a credit to all officials for their strong attendance helping greatly to the success of the carnival.

Congratulations to Paul Cooper, Sydney Branch Surf Life Saver of the Year. It was an extremely hard choice, deciding on only one from the five excellent finalists. Again there were only nine original nominees and from fifteen clubs this must leave us to wonder why not at least fifteen nominees.

It was gratifying to notice a marked improvement in the wearing of patrol uniforms throughout the past season. Hopefully this was not due solely to the running of the patrol uniform competition, which was duly won by North Cronulla, the prize being a new set of patrol uniforms.

Throughout the past season, with the exception of two clubs requiring to meet with the Board Executive, the standard of patrols by all clubs was very good. In my opinion I feel that the standard of patrols is getting better and hopefully this trend will continue. Thank you.

EMERGENCY SERVICES CO-ORDINATOR'S REPORT

This season has seen a few changes to the Emergency Services Section. J.R.B.3 was sold and replaced by a new Shark Cat similar to the O.R.B.2 boat. The Branch Radio Room has had a face-lift making it easier for two operators to use during rescues and the duty officers were placed on alphanumeric pagers making it easier to reach them at any time. The season also saw a greater acceptance of the duty officers by clubs due to a better understanding of their role at major incidents and a closer

working relationship with the Helicopter Rescue Service. If we could gain the co-operation of every club in the Branch by providing I.R.B., radio and experienced (local knowledge) lifesavers to be placed on an emergency call out list, the Sydney Branch 24 hour emergency call out system would be complete and remain as the best Surf Life Saving Call Out System in Australia.

During winter I will be endeavouring to have the 24 hour call out system accredited as an emergency rescue group and then make the police, ambulance, coast guard, etc. aware of our service. I also intend to try and come up with a way to use the service to help attract the ever elusive dollar.

The Branch has been approached by the Wollongong Aerial Patrol to see if we would like them to extend their surveillance area to cover the Sydney Branch. This service has been operating successfully in the Illawarra Branch for some time now. They offer a free service which does regular flights over the beaches to watch for sharks, boats in distress, etc. and report any problems to the clubs via Sydney Surf. The service will also add another group that can be called upon by clubs to help with searches, etc. The President of their club has been invited to attend our Club Captains Meeting in June to elaborate on their service.

To all people living in the Waverley area, a duty officer and a back up duty officer are needed for the Waverley area. Both should have a thorough knowledge of the Branch Emergency Service Protocols and be prepared to be on call 24 hours a day. A brief description of the role of the duty officer is on page 19 of the Branch Information Directory; a back up duty officer is required to fill in the duty officers absence. If you are interested in one of these positions contact me (Brad Taylor) or George Shales.

IRB SUPERVISOR'S REPORT

I nearly started this report with "the season under review..." but have changed my mind after a recent introduction to the "KISS" technique. As I contemplate "KISS" I realise that most management sort of people know to "keep it simple stupid".

As I further contemplate "Kiss" I wonder how far the principle has extended into Surf Life Saving and the IRB sphere.

The glossary of terms we use, for instance

HB MAT, UHF Channel 3, IRB, ORB, Bladder, PJI/KPA, Doing a solo, MSB Licence, ARC equivalent Ressuc, 27 Meg, He's in the turtle club, Drilled in the shore dump, Punching a wave, Lay the buoys, Tiller, Soft Hull, Rigid inflatable Pick up in Death Alley.

Is our vocabulary jargon? Does it isolate us from the "ordinary man on the beach", whoever that is. Does this isolation deter prospective drivers. Have we become "too elite" or do we think of ourselves as "too elite".

Then I think of competition, what a nightmare of rules, regulations, specifications, handbooks, bulletins, minutes, alterations, additions, interpretations that are all in a continual state of flux.

This leads me back to the "Halcyon" days of IRBs. An IRB was a "Duck", simply a sort of 2 man rescue board with motor.

In our search for perfection have we over complicated the IRB. Is it simply too hard for new people to understand. How many prospective new drivers just don't bother after looking at joining the elite?

RADIO SUPERVISOR'S REPORT

With the resignation of Radio Supervisor, Brad McDonogh, mid-way through the 1991/92 season I took great pleasure in filling in for the remainder of the season.


In finishing, I would like to thank all the operators of Sydney Surf for their help and support throughout the season and I hope to see them all return next season.

ORE SUPERVISOR'S REPORT

New operating procedures for the SA365 Dauphin were introduced at the beginning of the season. In summary they are

- 1. The helicopter will not land on a beach but will instead winch the doctor and paramedic down to the scene.
- 2. A 40x40 metre winch area is still to be provided around the patient.
- 3. Clear the 50x50 metre landing site and the approach paths to that site.

To complement the new procedures, a helicopter beach landing site book was produced to assist. In addition, duty officers were provided with training in helicopter general knowledge, safety and landing areas. A talk and video presentation were also given to club captains prior to the start of the season.

It is my intention that this basic course be conducted at the beginning of each new season with as many senior Branch personnel as possible in attendance.

Most helicopter operations in the Sydney Branch were conducted along South Head and in the Royal National Park and involved cliff rescue and medivacs respectively.

The Sydney Branch after hours call out number is now part of Helicopter Standard Operating Procedure (SOP) with duty officers liaising with the helicopter direct on channel one.

As yet a date has not been set for the intake of new volunteer crewmen into the Service.

On behalf of all the crew of the Westpac Life Saver Rescue Helicopter I would like to thank all of the radio operators, duty officers and the crew of the off-shore rescue boat for their assistance with the helicopter rescues and training programmes conducted during the season.



To all Clubs, the best for next season.



In conclusion, I would like to congratulate Cronulla S.L.S.C. in their outstanding win at the Australian Titles held this season



IRB examinations were under the control of Bernie Kelly and ORB awards through the respective examiners.


With the Board being restructured towards the end of the season meetings will be held on Examination only, so that problems faced throughout the season can be ironed out and new ideas being put to valuable use.

RESUSCITATION-RESEARCH-DEVELOPMENT-INSTRUCTION-MEDICAL PANEL'S REPORT

The Panel only had one meeting this year at the beginning of the season.

It was quite instructive as Dr. Mackie advised us of what had come up from the Conference at Lubeck saying that we are in advance of all countries in that we are the only ones to use oxygen in our resuscitation procedures.

The trouble with being the co-ordinator of this panel is you arrange a meeting and call for items to be placed on the agenda then a couple of days before the meeting, with nothing brought up for the agenda you have to make one up. I apologise for not calling for a meeting at the end of the season as I was involved in a car accident.

The one thing that came out of the meeting requiring further attention was that Coastline Medical Supplies advised clubs that the Amba Simulator in use is no longer available and pushing another Ambu Simulator (No. 2).

This is not true, however some clubs have purchased the Simular (No. 2) necessitating the making up of a new Gear Inspection Form to cover it. Also, as advised in my last Report if an alternative is to be taken there are two alternatives; Ambu Simulator or Laerdal Resusi-Ann, both of which are approved by ARC and some direction should be given to clubs which to buy.

WAVERLEY AND RANDWICK DISTRICT A.R.C. EXAMINATION TEAM REPORT

The Randwick/Waverley District Advanced Resuscitation Examination Team was, once again, very active this season. The team members - Tim Murray, Roger Habib, Paul Cooper, Peter Agnew and myself - conducted 36 separate examinations, with a total of 116 A.R.C. and 7 A.R.C.I. awards achieved during the season.

Due to the increased number of awards this season, an additional A.R.C. examiner is currently being trained and will be presented to Dr. Ian Mackie, for assessment, during the next season.

The team was also active in conducting an A.R.C. Instructors Seminar (which was well attended), conducting a trial of the single handed jaw thrust grip, assessing next oxygen resuscitation equipment, and attending briefings and examination reassessment with Dr. Ian Mackie.

The standard of candidate presented for examination during the season has been excellent. The team has received positive feedback from A.R.C. instructors, who have been encouraged by the uniform examination standards.

My thanks go to each of the team members, their calibre, commitment and dedication has been quite remarkable, especially considering the demands placed upon them by other lifesaving duties.

The team would like to thank club instructors for their hospitality and courtesy. Special thanks to Dr. Ian Mackie AM, who maintains a very close working relationship with our group. Thanks also to Troy Eady who assisted in several projects during the season.

CRONULLA-SUTHERLAND/ROYAL NATIONAL PARK RESUSCITATION REPORT

Because of the fact that it is impossible to do an update on 30 to 40 people in less than an hour without making a farce of the update it was not held at the Board Meeting in October and it was recommended that this be done by the examiners later in the season. Because of the recriminations by Chief Instructors that there was too great a variation by examiners a meeting was called for all Chief Instructors, District Supervisors and their Deputies to attend a meeting where it was demonstrated what would be expected of candidates.

All Clubs, Wanda to Burning Palms were represented except Cronulla who neither attended nor apologised. At this meeting it was stated that the examiners would be available every Monday night at Wanda for A.R.C. updates but the request was made that on the first few weeks they ring me and check on the number coming. The response was very poor and before Christmas less than 30 people were updated.

It was also state that an A.R.C. class would be run at Wanda Monday nights to increase the size of squads of candidates above 2 or 3 and to teach aspiring instructors how it was expected they would teach a squad. This was eventually started on January 26, with 18 candidates and 4 prospective instructors however the prospective instructors and 2 candidates withdrew.

Sixteen completed the course and with the exception of Peter Sullivan no prospective examiner assisted. It was unfortunate I was unable to arrange for him to do his first examiners.

At this meeting three members of Garie, three members of North Cronulla, two from Elouera indicated rather forcefully that they wished to obtain their A.R.C. Examiners and it was explained that if they helped with the instruction of the classes when they were commenced some would be put forward with each class, only Peter Sullivan of Garie assisted.

At Elouera Carnival the Captain of Cronulla Club demanded that I arrange for an update examination on Thursday, in 10 days time. 

CARNIVAL COMPETITION SUPERVISOR'S REPORT

The 1991-92 season has been one of an intense and varied nature and at times quite demanding on a dedicated band of Carnival Officials. Starting early in October with the Era Club hosting the Botany Bay Surf Boat Marathon, the season finished with a historic visit by a South African Surf Life Saving Team which competed against a Sydney Branch squad at South Maroubra Beach on May 16. Also during the season a team representing the Huntington Beach Junior Lifeguards (U.S.A.) competed in the Sydney Branch.



The season saw the inauguration of Competition Officials Education Programme which resulted in seventy five members of Sydney Branch being accepted as accreditated officials to championship level. 
